Narrative:

On Wednesday, January 15, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman reviewed the subject work-up for Christopher Gorak completed by the BCI Criminal Intelligence Unit.

SA Seitzman reviewed the work-up and noted the following:

Gorak's criminal history included arrests for OVI in 2000 and 2003, disorderly conduct in 2003, failure to confine a dog in 2004, and hunting without a license/wildlife violation in 2018.

SA Seitzman spoke with Middletown Deputy Police Chief Ryan Morgan, who confirmed that the Middletown Police Department had only one prior contact with Gorak, which was a traffic stop in 2000.

On Tuesday, January 14, 2025, SA Seitzman faxed a records request to the Butler County Sheriff's Office. On Wednesday, January 15, 2025, SA Seitzman received responsive records. SA Seitzman reviewed the records and did not note any relevant criminal history other than a ten-day jail sentence in 2003 for an operating under the influence conviction.

Good afternoon,

In regards to your request for records related to 6501 Germantown Rd Lot #329 from 2000-2024, unfortunately, the way our CAD system is set up to search for calls, we can only search via address and when the address is a mobile home park or apartment complex, it does not allow us to search by individual lots/units. In addition, our current system only goes back as far as 2020. For example when I search 6501 Germantown Rd in our CAD system from 2020-2024, it brings up 45 pages of calls and each page contains over 50 calls per page. I'd have to pull up everyone of these calls and read through the CAD report to see if it involved lot number #329 or Christopher Gorak. Therefore, we are unable to conduct a search for the address requested without having the specific date when the call for service would have been made. In regards to your request for any records related to Christopher Gorak DOB 02/09/1974, a search of our record management system yielded the attached results.
