On August 28, 2023, as part of an ongoing investigation of an officer involved critical incident (see CST Gill's Scene 1 report), Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Sarah Taylor was assigned to photograph the deceased, Jamie Overstreet (Overstreet), at Grant Medical Center (GMC) and to process Columbus Police Department (CPD) officers.

SA Taylor arrived at GMC and began to photograph Overstreet at 0151 hours. SA Taylor observed a tattoo on Overstreet's upper chest area as well as his upper right arm. Underneath his right shoulder, SA Taylor photographed a substantial amount of blood where one suspected bullet wound was observed. SA Taylor was given a brown paper bag that contained Overstreet's clothing and personal items that had been recovered from his body. SA Taylor cleared this location at approximately 0200 hours.

SA Taylor arrived and began to process officers at the CPD substation at approximately 0223 hours. Four officers were reported to have witnessed the shooting; however, they did not discharge their firearms. SA Taylor photographed the following officers and their firearms: Officer Kraig Gibson (2138), Officer Duane Derwacter (2749), Officer Andrew Durr (2754), and Officer Sean Evans (3050). All officer's firearms and extra magazines were loaded to their full capacity.

SA Taylor then photographed Officer **Constant and Constant and Const** the officer involved critical incident. SA Taylor collected Ofc. **Second** firearm, seated magazine, cartridges, and attached TLR-1 HL Streamlight as item 1. The firearm was a Smith & Wesson, M&P9 M2.0, semi-automatic handgun (SN: with one cartridge in the chamber and 12 cartridges in the seated magazine (capacity of 17). Ofc. stated he did not use his two additional magazines that were secured in his gun belt. SA Taylor photographed these two magazines and verified each was loaded to full capacity. SA Taylor cleared the CPD substation at approximately 0240 hours and reported to Scene 1.

All evidence collected from the hospital and Scene 2 was released to CST Gill.
