**Narrative:**

On October 9th, 2025, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Grove City Police Department (GCPD) to investigate an officer involved critical incident. As part of the investigation, Special Agent Doug Eveslage responded to the Grove City Police Department annex at the above-mentioned address to process the involved officers.

SA Eveslage arrived at the annex at approximately 2345 hours. He was advised that five GCPD officers had discharged their duty weapons. All involved officers located at were observed to be in their agency issued uniforms and advised they were dressed as they were at the time of the incident when photographed. The specifics of each officer are detailed below:

- ██████████ (Officer #1) - GCPD: Reportedly discharged his duty pistol during the incident. His duty pistol was a Glock 45 9mm (S/N: ██████████), with a TLR-1 HL Streamlight weapon light attached to the frame and a Holosun optic attached to the slide. It was found with zero 9mm cartridge in the chamber or in the seated magazine. His duty belt contained two additional fully loaded magazines. His pistol and empty magazine were collected as Item #1.
- ██████████ (Officer #2) - GCPD: Reportedly discharged his duty pistol during the incident. His duty pistol was a Glock 45 9mm (S/N: ██████████), with a TLR-1 HL Streamlight weapon light attached to the frame and a Holosun optic attached to the slide. It was found with one cartridge in the chamber and a seated magazine containing 17 cartridges. His duty belt contained one additional fully loaded magazine. His pistol, magazine, and cartridges were collected as Item #2.
- ██████████ (Officer #3) - GCPD: Reportedly discharged his duty rifle during the incident. His duty rifle was a Daniel Defense DDM4

(S/N: [REDACTED]), with an Odin weapon light attached to the right siderail and a Holosun optic attached to the top rail. It was found with one cartridge in the chamber and a seated magazine containing 25 cartridges. His duty vest contained two additional magazines loaded with 28 cartridges. His rifle, magazine, and cartridges were collected as Item #3. His Glock 45 duty pistol was visually and physically checked, and all three magazines were fully loaded and one additional cartridge was in the chamber.

- [REDACTED] (Officer #4) - GCPD: Reportedly discharged his duty rifle during the incident. His duty rifle was a Daniel Defense DDM4 (S/N: [REDACTED]), with an Aimpoint optic attached to the top rail. It was found with 21 cartridges in the seated magazine. His duty vest contained one additional magazine loaded with 28 cartridges. His rifle, magazine, and cartridges were collected as Item #4. His Glock 45 duty pistol was visually and physically checked and all three magazines were fully loaded and one additional cartridge was in the chamber.

SA Eveslage transferred the involved officers' property to Crime Scene Special Agents Aja Chung and Brittany VanBibber at approximately 0130 hours for further processing.
