Narrative:

On January 23, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente responded to the Cuyahoga County Medical Examiner's Office, 11001 Cedar Avenue, Cleveland, Ohio. 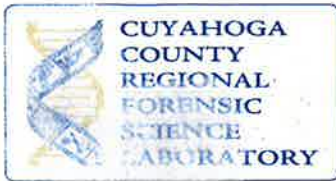

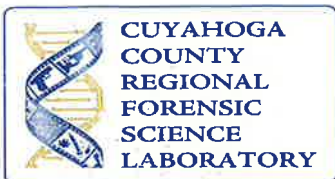

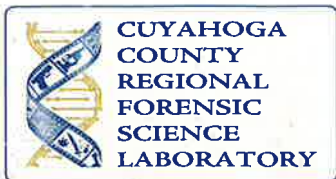
