GENTLEMEN:—The receipt is acknowledged of your letter of November 1, 1922, transmitting for my examination transcript in duplicate of the record of the proceedings relating to the proposed sale to T. S. O'Bannon of Nashport, Ohio, of 29 acres, more or less, of abandoned Ohio Canal property in Licking Township, Muskingum County, Ohio; said lands abutting lands now owned by said T. S. O'Bannon.

I note that owing to the poor character of this land, due to its being subject to overflow, you have appraised the same at \$1.00; and that the main object of the proposed sale is to have Mr. O'Bannon take care of the drainage of water flowing out of the canal owing to a large breach in its embankment, thus saving the State from large prospective damages and considerable expense for repairs.

I have carefully considered the transcript submitted, and have concurred in the proposed sale, as indicated by my having appended my signature to the resolutions.
