Narrative:

On Thursday, July 21, 2022, at 1430 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Eric Lehnhart (Lehnhart) arrived at 1044 Belmont Avenue, Youngstown, Ohio 44504, Mercy Health-Youngstown Hospital Protective Services, to collect evidence.

In a report dated Tuesday, July 19, 2022, Mercy Health Police Officer Patrick Demski wrote:

On 07/19/2022 at 1940 hrs, bullet fragments were removed from Imonte hacket. [sic] Surgery staff handed over bullet fragments to me at 1942 hrs. At 1945 hrs I secured the bullet fragments in evidence locker number one.

On Thursday, July 21, 2022, at 1455 hours, Mercy Health, Assistant Police Chief James Craven, released the bullet fragments to SA Lehnhart for transport to the Richfield Regional Laboratory.
