Narrative:

On July 3, 2024, Special Agent (SA) Josh Rammel (Rammel) reviewed a text message thread provided by Alyson Taylor (Alyson) regarding interaction she had with her father, deceased individual George Eric Taylor (Taylor) prior to Taylor's interaction with the Wood County Sheriff's Office (WCSO) on June 16, 2024.

On June 27, 2024, Alyson contacted SA Rammel and informed him that she had been in contact through text messages with Taylor on the morning of June 15, 2024, up until around 2130 hours on June 15, 2024.

SA Rammel observed in the text message thread that Taylor's initial text was on June 15, 2024, at 1016 hours. Taylor informed Alyson that he and his wife Jessica Taylor (Jessica) were getting a divorce. The conversation continued with a break between messages until 2130 hours when Taylor began making comments that he was "hurting" and with "any luck" Taylor would not do anything stupid. Taylor informed Alyson that he loved her and that he would "get on that" when Alyson mentioned therapy.

Taylor ended his contact with telling Alyson that he was "sorry for being a bad dad".

Alyson sent a final message on June 16, 2024, at 0756 hours wishing Taylor a "Happy Father's Day".
