APPROVAL—RESERVOIR LAND LEASE AT INDIAN LAKE, OHIO, FOR THE RIGHT TO USE AND OCCUPY FOR DOCKLANDING, GARDEN, LAWN, GENERAL BUSINESS AND DRIVEWAY PURPOSES—J. R. BEATLEY.

COLUMBUS, OHIO, July 12, 1934.

DEAR SIR:—This is to acknowledge the receipt of a recent communication over the signature of the Chief of the Bureau of Inland Lakes and Parks of the Division of Conservation in your department, submitting for my examination and approval a reservoir land lease, in triplicate, executed by the Conservation Commissioner, under authority of section 471, General Code, to one J. R. Beatley of Russells Point, Ohio.

This lease, which is one for a stated term of fifteen years, and which provides for an annual rental of \$225.00, payable semi-annually, grants and demises to the lessee above named the right to occupy and use for docklanding, garden, lawn, general business and driveway purposes, the waterfront and State reservoir land in the rear thereof at Indian Lake, Ohio, which parcel of land is more particularly described as follows:

“Beginning at an iron pin at the northwest corner of Lot No. 15, of Burkhardt’s Allotment of lands at Russells Point and extending thence

in a northeasterly direction along the northerly line of Lot No. 15, 115.9 feet to the northeasterly corner thereof; thence North 83° 32' East, 116.8 feet along the northerly line of the Orchard Island road to an iron pin; thence North 6° 16' West, 150' more or less, to the water line of Indian Lake; thence westerly and southwesterly along the water line of said Indian Lake to the intersection of the center line of the alley lying between Burkhardt Avenue and the Orchard Island Road; thence in a southeasterly direction along the center line of said alley, 85 feet, more or less, to the place of beginning, reserving therefrom a five-foot strip of land off of the westerly side of the above described tract for alley purposes, to be left open for the free use of the public."
