APPROVAL—RESERVOIR LAND LEASES, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, DESIGNATED LANDS, INDIAN LAKE, LOGAN COUNTY, OHIO, TO THREE LESSEES.

COLUMBUS, OHIO, January 5, 1939.

HON. L. WOODDELL, *Conservation Commissioner, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval, a number of reservoir land leases executed by the State of Ohio, through you as Conservation Commissioner to the several lessees therein named, by which there were leased and demised to the respective lessees therein named a number of parcels of reservoir lands owned by the State at Indian Lake, Ohio.

These leases, designated as to the names of the several lessees, the locations of the parcels of land leased, and the annual rental provided for therein, are as follows:

Henry Barnes—Permission to occupy and use for commercial boat-landing and bait stand purposes only, that portion of the easterly side of the Orchard Island Road, Indian Lake, beginning at a point that is two hundred (200) feet southerly from a stake marking the northwesterly

corner of the lands owned by the Orchard Islands, Inc., along the southeasterly side of the Orchard Island Road, and extending thence southerly a distance of fifty (50) feet to a point that is two hundred and fifty (250) feet southerly from the said northwest corner of the lands of the Orchard Islands, Inc., being in and a part of the Northeast fractional quarter of Section 36, Town 6 S., Range 8 E., Washington Twp., Logan County, Ohio.—Annual Rental \$15.00.

Rufus M. and Della Neely—Permission to occupy and use for cottage site, docklanding and business purposes only, a small dredge island on the easterly side of Orchard Island Road in Indian Lake, located about forty (40) feet north of the Flume under Orchard Island Bridge, and being a part of the east-half of Section 36, Town 6 South, Range 8 East, Logan County, Ohio, with the privilege of dredging the adjacent shallow water and of depositing the dredgings upon said island so as to raise the level thereof to a height sufficient for cottage sites; also the privilege of constructing and maintaining a bridge to connect said island with Orchard Island Road; also permission to construct and maintain such retaining walls around the margin of said island as may be necessary for protecting the shore line thereof against the action of the waves; also permission to construct and maintain necessary docklandings for the use of the occupants of cottages located upon said island.—Annual Rental \$100.00.

Frank J. Tucker—Permission to occupy and use for cottage site, boathouse and docklanding purposes only, that portion of the State Reservoir land including Lot No. 42, of the reallocation of Minnewauken Island in Indian Lake; said island being part of Virginia Military Survey No. 12276, Stokes Township, Logan County, Ohio.—Annual Rental \$30.00.

Upon examination of the leases hereinabove referred to, all of which are for a stated term of fifteen years, I find that each and all of the same have been properly executed by you as Conservation Commissioner and by the respective lessees therein named.

I further find, upon examination of the provisions of these leases and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which these leases are executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving these leases, and each of them, as to legality and form, as is evidenced by my approval endorsed upon the leases and upon the duplicate and triplicate copies thereof, all of which are herewith inclosed.
