**Narrative:**

On September 22, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier received cruiser video footage from Springfield Police Lt. Beau Collins. The videos contained footage from the officer's vehicles, who were either involved in the incident or responded to the Officer-Involved Critical Incident (OICI).

The following officers were identified as having cruiser video footage involving the incident: [REDACTED], Officer Zachary Massie, and Officer Beau Ray.

The following summary of the recorded videos highlights the key points that the author deemed most relevant, although it does not provide a verbatim account. Not all videos were reviewed in their entirety. It is suggested that the full video recordings be reviewed. SA Frazier reviewed the video recordings below and noted the following information:

**[REDACTED] Cruiser Video:**

Three (3) total videos showing different aspects of the cruiser. The information on the video noted the time was approximately 1131 hours and belonged to Car [REDACTED].

- [REDACTED] was sitting stationary, running traffic near an intersection.
- 02:00 minute mark – [REDACTED] cruiser began to move forward and a silver Ford truck was observed passing in front of him. [REDACTED] pulled out directly behind the silver Ford truck.

- 02:15 minute mark - The silver Ford truck made a left turn, and activated his in-car siren.

- 02:20 minute mark - The silver Ford truck tapped their brakes briefly, before accelerating away from the cruiser and driving through a stop sign without braking.
- 02:28 minute mark - [REDACTED] stopped at the stop sign and the subject vehicle is seen a large distance away.

- 02:35 minute mark - ██████████ turned off his sirens.
- 02:40 minute mark - The subject vehicle, observed in the distance, turned right onto a side street.
- 02:43 minute mark - ██████████ attempted to parallel the vehicle and continued to look for the vehicle in the area.
- 03:29 minute mark - The cruiser video concluded.

## Officer Zachary Massie Cruiser Video:

Two (2) total videos showing different aspects of the cruiser. The information on the video noted the time was approximately 1136 hours and belonged to Car 66.

- 03:25 minute mark - Officer Massie arrived on scene.
- 06:55 minute mark - Detective Emory moved police Van 40.
- 08:05 minute mark - Officers are observed loading the subject into the back of police Van 40.

- 08:47 minute mark - Police Van 40 was seen leaving the scene with its overhead lights activated. A cruiser left at the same time.
- 13:18 minute mark - Officers were seen putting up crime scene tape.
- 13:26 minute mark - An ambulance is observed passing by the scene.
- 40:27 minute mark - The cruiser video concluded.

### Officer Beau Ray Cruiser Video:

Three (3) total videos showing different aspects of the cruiser. The information on the video noted the time was approximately 1136 hours and belonged to Car 2.

- 02:55 minute mark - Officer Ray arrived on scene and Officer Kitchen exited the cruiser and went toward the location of the subject.
- 03:14 minute mark - Officer Ray moved his cruiser to face down toward the alley way, which captured officers' actions on scene.
- 04:14 minute mark - The subject was seen trying to stand up, before Officer Kitchen assisted him to the ground.

- 04:21 minute mark - The subject was struggling on the ground, and Officer Kitchen placed his knee on the subject.



*Officer Ray Cruiser Video - 04:29 Minute Mark*

- 05:12 minute mark - Officer Warnock approached the subject with a towel.
- 05:37 minute mark - Officer Massie arrived with a medical bag.
- 06:05 minute mark - Multiple officers were observed providing medical aid to the subject.
- 09:17 minute mark - The cruiser was moved so officers could load the subject.
- 09:55 minute mark - Officers were observed carrying the subject and placing him in the back of police Van 40.

- 10:35 minute mark - Van 40 and Officer Ray in his cruiser, both left the scene, with their lights and sirens activated.
