Narrative:

On April 27, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau (SAS Barbeau) received a declination memo from the Meigs County Prosecutor's Office regarding the officer-involved critical incident (OICI) which occurred in Albany, Ohio, on July 8, 2025. The prosecutor declined to pursue criminal charges regarding the actions of the Meigs County Sheriff's Office in relation to the death of Patrick McDaniel, who was involved in the incident.

All evidence in this case has been returned to the requesting agency. SAS Barbeau and BCI Special Agent Kyle Douglass (SA Douglass) reviewed this investigation throughout this investigation. It was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.

This case is closed.

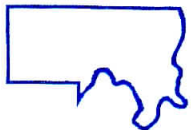


