APPROVAL, CONTRACT BETWEEN STATE OF OHIO AND E. W. HAWES, DOING BUSINESS AS THE SEWAH STUDIOS, MARIETTA, OHIO, FOR FURNISHING OF MARKERS, MONUMENTS, AND MAPS FOR THE OHIO REVOLUTIONARY MEMORIAL TRAIL AT AN EXPENDITURE OF \$20,000.00—SURETY BOND EXECUTED BY THE SOUTHERN SURETY COMPANY.

DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Ohio Revolutionary Memorial Commission, and E. M. Hawes, an individual doing business as The Sewah Studios, Marietta, Ohio. This contract which is made pursuant to Senate Bill No. 91 (113 Ohio Laws, 547), covers the furnishing of markers, monuments and maps for the Ohio Revolutionary Memorial Trail in accordance with the form of proposal dated June 2, 1930.

There has been submitted the certificate of the Director of Finance to the effect that there are unencumbered legal balances appropriated in a sum sufficient to cover the obligations of the contract. A contract bond of the Southern Surety Company has been submitted in the penal sum of twenty thousand dollars (20,000.00), sufficient to cover the amount of the contract. Evidence has further been submitted to show that plans and specifications have been properly prepared and filed with the Auditor of State, and that competitive bidding was had in accordance with Section 2 of House Bill 513, which appropriates the money for your commission, and Section 7 of House Bill 510 of the 88th General Assembly.

Finding said contract and bond in proper legal form, I have this day noted my approval and return the same to you, together with all other data submitted in this connection.
