Investigative Activity: Recovered Cellular Phone Analysis Review

Narrative:

On October 3, 2022, Special Agent (SA) Jon Lieber (Lieber) obtained a search warrant through the Summit County Common Pleas Court for the following items:

- **Motorola Moto e (2020) – Model #XT2052DL – Serial #ZY22CMPR9C (Matrix Item #015)**
- **BLU View 2 – Model #B130DL – Serial #1090339021031113 (Matrix Item #021)**

On October 3, 2022, the above listed cellular phones were submitted to the Ohio Bureau of Criminal Investigation Cyber Crimes Unit for analysis.

On November 17, 2022, SA Joseph Goudy (Goudy) received the results of the phone analysis. SA Goudy reviewed the analysis and could not locate anything relevant to this incident.

Matrix Item #015

The last “incoming” call answered by Everett Martin was on September 27, 2022, at 8:08:09 PM, duration of 3 minutes and 58 seconds. The call indicated it was from “Kassandra Noah Girlfriend,” [REDACTED] This phone call was between Everett Martin and his son, Noah Martin. This corroborated the information Noah Martin (Noah) provided as to when the last time he spoke with Everett Martin.

The last “outgoing” call Everett Martin made was to “Kassandra Noah Girlfriend” [REDACTED] duration five seconds. This call corroborated the information of Everett Martin asking for Noah to call him back.

The last Facebook message sent by Everett Martin was to “Mirandy Zedi” (Facebook identification #100059230900031), on September 28, 2022, at 7:27:11 AM. Everett Martin sent the message, “Sorry,” followed by the last Facebook message received from “Mirandy Zedi,” on September 28, 2022, at 2:23:06 PM asking, “How’s ur day goin buddy?” The lengthy Facebook messaging between Everett Martin and Mirandy Zedi occurred between September 16, 2022, at 2:58:07 PM, and September 28, 2022, at 2:23:06 PM.

Matrix Item #021

This cell phone did not have any relevant information pertaining to this investigation. The last call made on the cell phone was on December 24, 2021, at 11:53:25 AM, when Everett Martin called his son, Noah Martin, at [REDACTED] The last text message occurred on December 22, 2021, which also had no bearing on this investigation.

No photographs, video or device locations were found to be relevant to this investigation. The cellular phones appear to belong to Everett Martin, due to the fact that there are personal calls and texts between him and his ex-girlfriend, Courtney Digenova. In addition, there were also phone calls and messages between Everett Martin and his sister, Betsy Martin. The cellular phone analysis information was placed onto one (1) SanDisk USB 32 GB thumb drive; the USB drive was placed into the item section of the physical case file, labeled as Item C.
