#### Narrative:

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Tiffany Najmulski SA (Najmulski) received documents from the Celina Police Department (CPD), Mercer County Sheriff's Department and Coldwater Police Department. The records which were requested included any reports pertaining to the December 31, 2024, officer-involved critical incident (OICI). SA Najmulski reviewed the documents and noted the following:

1. Celina Officer Nate Miller cited the following in his report: N. Miller Follow Up Statement On 12/31/2024 at 1330hrs, "I was dispatched to 126 W. Logan St. reference possible residential camera footage of Moses Allik (Allik). Upon arrival I spoke with Samuel Thorp. He stated that he heard about the incident a Marathon Gas and checked his cameras. He said that at 0257hrs, a male is seen walking across W. Logan and walking to the porch of 122 W. Logan. Thorp then shown me the footage. I observe Alik walk across W. Logan Street and on the porch of 122 W. Logan. At this time I could not see Alik but could hear him yelling. Shortly after, he is seen walking down from the porch and walking to the east. I had Thorp email the video and then left his residence."

SA Najmulski made SA Doug Burke (Burke) aware of the video. SA Burke obtained the video and attached it to the case file.

2. Celina Police Department spoke to a woman by the name of Roselee Akilang (Akilang) who confirmed that Allik was her cousin. Akilang went to Coldwater Hospital and made a positive identification on the decedent, Allik.

The Celina Police Department report for the OIS incident, 24-012629, is attached to this investigative report as well as the Mercer County Sheriff's Department and the Coldwater Police Department report. Please refer to the attachment for further details.

On 12/31/24 at 0330 hours, I was contacted and requested to assist in a shooting investigation that occurred at 303 S Main St. in Celina.

While enroute, I was advised that this was an officer involved shooting where a Mercer County Deputy had discharged his duty weapon at the gas station. I was advised of one victim/suspect that was in Coldwater ER and Detective Taylor was enroute there. I responded directly to the scene.

I found that a permitter had already been established by neighboring jurisdictions. Chief Wale was already on scene along with supervisors from Mercer County SO. Sgt Crosby and Ptl. Balthis were also on scene and I was told were involved in the incident.

I spoke with Chief Wale. He advised me that, there was an attempted car theft in the parking lot that units were responding too. They then encountered the suspect in the attempted car theft, in the parking lot, who was stabbing himself with a knife. Wale stated that the male then charged at Deputy Spencer Heinl with the knife over his head. He stated that they believed the male was possible a Moses Alik, but ID had not been confirmed. He also informed me that the male shot was deceased at Coldwater ER and that Ohio BCI was enroute to investigate the shooting.

I was familiar with Moses having at least on prior encounter. I was told that a possible family member had come to the area and showed an ID belonging to Moses to a State Trooper at the intersection of Warren St and Walnut St. The family member was an aunt "Rosalee" and was asking if her nephew was involved. They photographed the ID and gave it back to her but no information was released.

I then went to Coldwater where Det Taylor was. Through photos obtained by LEADS and OHLEG we both believed that the decedent was Moses Alik, but waited for BCI to help confirm before making notification to family.

I returned to the scene. Sgt Chisolm with the Auglaize County Sheriffs Office was on scene assisting in a perimeter, While speaking with him, he told me that he received a screen shot from a friend of a Facebook post. He showed it to me which showed police cruisers in the background, an ambulance and officers standing in the parking lot of Marathon. The post was from a Chad Mabry. The posted stated that a man with a knife opened his back door and took off then was shot by police. The picture attached to the post appeared to be taken from 125 W Logan St. on the back porch looking toward Marathon.

A short time later a male later identified as Betwell Bellu, came from 316 S Walnut St and began speaking with a Deputy on permitter. Det Taylor and I went and spoke with Betwell as he had stated he was the cousin of Moses and wanted to know if Moses was shot. I asked Betwell why he may believe his cousin was involved. He stated that earlier in the night around 12 am he (Moses) was over at this residence. Betwell described him as being "on something". He stated that he has seen Moses "drunk" but this was something different. Betwell stated that he made comments about people chasing after him. Betwell went on to tell me that he got into a car, he pointed at an abounded Pontiac sedan. I know this vehicle to be inoperable and belong to Matthew Schweiterman. Betwell stated that he got in the vehicle and acted like he was driving. Moses later got out and sat on the concrete wall of the parking lot. Betwell stated that was when he went back inside the house.

I asked Betwell what he was wearing, He stated he had on a dark colored "puffer jacket". I further asked him if he had any distinct tattoos. He told me he had Marshallese tattoos on the back of his legs.

I asked Betwell about family he stated that he lived at the apartments near the fairgrounds. "Williamsburg Square". (Moses' address through the BMV was 1400 W Market Apt 4.) I advised him we would get back with him if we had any questions but were not releasing any information at this time.

At that time Special Agent Tiffany Najmulski and Special Agent Doug Burke arrived on scene. I advised SA Burke of the Facebook post and of speaking with Betwell.

SA Burke advised that SA Najmulski would be leading the investigation but requested that I assist him in speaking with area residents and the clerks inside the gas station.

We went inside and made contact with Yashkumar Patel, Harsh Patel and Rashminhumar Prajapati. Both Patel's were working in the store at the time of the shooting.

The began to tell us that the male, described as the decedent. Had frequented the store in the past, stating that he often steals alcohol. They stated that when he came that night. They made comments to him about stealing. He then left and went outside. They then stated that he tried to steal a customers car "Dot" (later identified as the original complainant Errin Johnson). They began to show us video that occurred at approx. 0250 on the outside cameras. A silver car pulls up to the gas station on the North Side, male gets out and enters the store, Moses then enters the car from the passenger side and jumps in the driver seat. Johnson comes out and confronts Moses and he quickly gets out. It appears an argument started in the parking lot, but Moses walks off.

Burke requested all video inside and out. They made arraignments to get him the video.

Det Taylor and Burke spoke about a next of kin notification, which was later completed by Det Taylor and MCSO.

A short time later, SA Burke and I went to 125 W Logan ST to speak with Chad Mabry about the photo. Chad came outside and agreed to speak with us. He stated that earlier in the night, he was in the front of his residence. He heard his dog bark and went towards his kitchen and noticed the door on the North side of his residence leading into his kitchen was open. He looked out further and saw a male who he described as an "islander" standing in the parking lot near his vehicles. Chad stated that the door was unlocked but believed that the male had entered his home then walked out when he heard his dog.

Chad then stated that he stepped outside and the male began to walk back toward Marathon. Once in the parking lot he stated that the Police came and began yelling at him to "drop the knife". He stated that was when he heard gunshots. Chad admitted he took a photo of the incident. We then viewed the photo on his phone that was blurry and showed the moments leading up to the shooting. He then told Burke had had videos. He agreed to send those to him.

I did ask Chad if he (male that he encountered) had a knife. He stated that he did not see one but the Police were yelling at him to drop a knife.

We then checked 121 and 121 1/2 for any residents but received no response.

SA Burke later requested a list of squad members and the original reportee information. I provided that to him and NCIC print outs for Moses Alik.

I further checked with Zuma Automotive (314 S Main St) for video and reviewed it. The video only showed the front of the 303 S Main St. This video showed only the vehicles responding to the incident and not the shooting. I did advise SA Najmulski of this.

I then assisted other units on the permitter until the scene was processed.

Nothing Further at this time.

On 12/31/2024 at 1330hrs, I was dispatched to 126 W. Logan St. reference possible residential camera footage of Moses Allik. Upon arrival I spoke with Samuel Thorp. He stated that he heard about the incident a Marathon Gas and checked his cameras. He said that at 0257hrs, a male is seen walking across W. Logan and walking to the porch of 122 W. Logan.

Thorp then shown me the footage. I observe Alik walk across W. Logan Street and on the porch of 122 W. Logan. At this time I could not see Alik but could hear him yelling. Shortly after, he is seen walking down from the porch and walking to the east.

I had Thorp email the video and then left his residence.

I then went to 122 W. Logan Street. There I spoke with a Matthew Wadsworth. I asked him if anything was missing to moved from his porch. He said no. I asked him if his residence was locked and he said yes. I told him if he noticed anything out of place or missing to contact the Celina PD. He said he would.

I then left.

Statement of Isaac Daniel Incident on 12/31/2024

I was riding with Ptl. Balthis on 12/31/2024 when we were dispatched to 303 South Main Street, Marathon gas station.

Dispatch stated a male was sitting in the caller's vehicle, attempting to take it. We arrived at the Marathon and began talking to the vehicle owner, who was the caller. He advised that a male in a dark puffy coat, later identified as Moses Alik, was sitting in the driver seat of his vehicle when he had exited the store. Ptl. Balthis then took a brief statement from the caller, who indicated Moses wasn't acting right and seemed to be under the influence of some sort of intoxicant, by stating "he was jacked out of his mind." Ptl. Balthis then asked him to stay at the gas station as we patrolled the area, looking for Moses.

While patrolling the area, Sgt. Crosby informed Ptl. Balthis that he was going to patrol the area and asked Ptl. Balthis to return to the gas station to take a full report from the caller. While gathering the callers report and information the gas station clerk came outside and informed Ptl. Balthis that they had the incident on camera. We walked inside to review the footage and saw the suspect on camera showing him currently behind the gas station holding a knife to his neck.

At this time Ptl. Balthis radioed to dispatch and Sgt. Crosby that the suspect was behind the gas station with a knife. Ptl. Balthis then exited the gas station and unholstered his duty weapon and began giving commands to the suspect, ordering him to drop his knife. During the incident I remained on the north eastern corner of the building about 30 yards from the suspect.

While Ptl. Balthis was ordering Moses to drop the knife, he stabbed himself in the left side of his neck multiple times. At this time Sgt. Crosby arrived in the north west alley behind the gas station, armed with his taser. Deputy Heinl arrived behind the gas station from the south with his duty weapon unholstered. Moses then dropped the knife as Sgt. Crosby tased him and all three officers began moving in, trying to secure Moses and the knife. Ptl. Balthis was directing Deputy Heinl to join in on him. During this time Moses's movements were very sporadic and irregular.

While being tased Moses attempted to pick up the knife while being ordered not to. Moses failed to pick the knife up the first time and was tased again. Officers where still moving in while attempting to secure him. During his second attempt Moses was able to pick up the knife and swing it around. At this time officers began backing up and continued to order him to drop the knife. Moses turned towards Deputy Heinl with his knife raised and began approaching him. Deputy Heinl then fired 4-5 rounds at Moses, who then dropped the knife and fell to the ground.

Ptl. Balthis then secured the knife and holstered his duty weapon. Sgt. Crosby and Deputy Heinl also secured their weapons and began handcuffing Moses. After he was handcuffed Sgt. Crosby and Ptl. Balthis began applying first aid to Moses, while Deputy Heinl went to his cruiser to get his med kit. I asked officers if I could assist in any way, and Ptl. Balthis asked me to retrieve gloves from the trunk of his cruiser. I was unable to locate any.

After removing his jacket Ptl. Balthis began to apply pressure to Moses's left hip as it was actively bleeding. EMS was dispatched and arrived shortly after. When EMS arrived, Moses was unhandcuffed so the paramedics could better assist him. EMS worked on Moses and then set him on the gurney and loaded him into the squad to stabilize him before transportation. Paramedics aided Moses in the squad on scene for a short time before transporting him to Coldwater hospital. At this time, I remained around Ptl. Balthis's cruiser while officers secured the scene. End.

### 01/02/2025 07:31:56 Patrick Crosby

\*On 01-01-2025 at approx. 1736 hrs, I, Sgt. Patrick Crosby, was ordered to make this statement/report by Chief Thomas Wale. I submit this statement/report at his order as a condition of my employment and upon pain of discipline/termination. I demand that a representative/attorney be present before proceeding with any interview or writing any report. I hereby invoke my rights under Garrity v. New Jersey, 385 U.S. 493 (1967) and Spevack v. Klien, 385 U.S. 551 (1956). It is my belief and understanding that this report/statement is for internal purposes and will not and cannot be used against me in any subsequent proceeding.\*

On 12-31-2024 at approx. 0252 hrs, Off. Balthis and I were dispatched to Marathon, 303 S. Main St., on a report of a male attempting to enter into and steal a vehicle at the business. Dispatch advised that the suspect was described as wearing jeans and a "puffer" jacket.

Off. Balthis arrived on the scene before me, making contact with the reportee, Errin Johnson, and getting preliminary information. Off. Balthis indicated that he was going to check the area for the suspect, to which I advised him to remain on the scene and get all information for the complaint and that I would check the area for the suspect. I also observed Dep. Spencer Heinl of the Mercer Co. Sheriff's Office in the area.

While in the 200-B of S. Walnut St. checking the area, Off. Balthis advised over the radio that the suspect was currently behind the business at 303 S. Main St. with a knife to his neck. He stated that the suspect was wearing a purple puffer-style jacket.

I proceeded south on S. Walnut St. and turned eastbound onto W. Warren St., pulling southbound into the north/south alleyway directly behind (to the west of) 303 S. Main St. Dep. Heinl pulled into the same north/south alleyway from the south and Off. Balthis exited the business from the front (east) side.

We observed a male, later identified as Moses Alik, standing in the parking lot of 303 S. Main St. to the northwest of the building. Mr. Alik was observed to be wearing a purple puffer-style coat. Off. Balthis was calling out that Mr. Alik had a knife and I immediately observed that Mr. Alik stab himself multiple times in the neck with what appeared to be a kitchen knife. Off. Balthis, Dep. Heinl, and I repeatedly ordered Mr. Alik to drop the knife. Mr. Alik refused to comply. Off. Balthis and Dep. Heinl had Mr. Alik covered with their handguns, so I drew my taser and continued to order Mr. Alik to get on the ground. I then proceeded to deploy my taser, striking Mr. Alik on the front left side of his body. The taser was not immediately effective and Mr. Alik remained standing. At one point, Mr. Alik's hand appeared to touch one of the taser wires, either accidently or in an attempt to remove the taser probe. At that point, I observed that he dropped the knife.

Off. Balthis, Dep. Heinl, and I continued to give orders to Mr. Alik, ordering him away from the

knife and to the ground. Mr. Alik continued to refuse to comply, stooping down and retrieving the knife off of the ground. As the taser was ineffective, I dropped it and transitioned to my handgun as Mr. Alik raised the knife and proceeded to approach Dep. Heinl. Dep Heinl fired several shots, striking Mr. Alik. Mr. Alik fell to the ground.

Off. Balthis, Dep. Heinl, and I then approached Mr. Alik, with Off. Balthis removing the knife. We turned Mr. Alik over, with Off. Balthis taking control of his right arm and Dep. Heinl taking control of his left arm. I then handcuffed Mr. Alik, who was still struggling against us and attempting to sit up. I called out "shots fired" on the radio and Dep. Heinl requested squad respond to the scene.

We then turned Mr. Alik back over onto his back, searching under his clothes in an attempt to locate his injuries. Off. Balthis called out to Dep. Heinl to retrieve a medical kit if he had one available. I located an entry gunshot wound to Mr. Alik's upper left leg in the area of his hip. He applied pressure to this gunshot wound with his hand. Off. Balthis opened Mr. Alik's coat and lifted his sweatshirt, locating a second gunshot wound to the middle of his chest. I retrieve a bandage from a medical kit Dep. Heinl had retrieved, putting pressure on the gunshot wound to his chest. Off. Balthis then asked Dep. Heinl if he had a chest seal, which he provided to me. Off. Balthis was able to clear blood off of Mr. Alik's chest and I applied the chest seal over the gunshot would to his chest. I also observed several knife wounds to the left side of Mr. Alik's neck under the jaw that did not appear to be actively bleeding. While attempting lifesaving measures, Mr. Alik made suicidal comments to us telling us, "I wanna die."

Celina FD squad arrived on the scene and requested that we removed Mr. Alik's handcuffs so they could easier treat his injuries. I leaned Mr. Alik forward and removed his handcuffs.

Celina FD squad cut Mr. Alik's coat off and we assisted in lifting him onto their cot. He was loaded into the squad where Celina FD squad continued lifesaving efforts. Off. Balthis and I entered the squad and assisted Celina FD members, as Mr. Alik was continuing to struggle against them. I took hold of and restrained his right arm to assist squad members as they put in an IV line, as Mr. Alik was flailing his arms around and trying to pull away. As Celina FD Squad was continuing lifesaving efforts, Mr. Alik made further suicidal comments, stating "kill me."

Once Mr. Alik had become less agitated, I advised Off. Balthis to secure the scene with crime scene tape.

Celina FD squad then transported Mr. Alik to Coldwater ER.

I made contact with Asst. Chief Harting, advising him of the situation, and then contacted Det. Taylor, advising him of the situation and requesting that he proceed to Coldwater ER to attempt to identify Mr. Alik and get any pertinent photographs.

I proceeded to take overall photos so as to document the location of all items on the scene. I was advised that Ohio BCI would be responding to process the scene and take control of the investigation.

I was approached by Ohio State Highway Patrol, who had been assisting in securing the parameter. They indicated that they had been approached by a Marshallese female, asking the identity of Mr. Alik. At that time, we had not positively identified Mr. Alik. The Marshallese female had provided an Ohio ID for Mr. Alik which appeared to match the description.

Chief Wale arrived on the scene and Off. Balthis and I proceeded to the external parameter before being transported back to the Celina PD. I was later advised that Mr. Alik was the suspect in an attempted burglary at a residence where a knife had been displayed on Logan St. prior to the shooting.

On 01/01/2024 at 1732 hours, I, Ptl. Kyle Balthis, was ordered to make this statement/report by Chief Thomas Wale. I submit this statement/report at his order as condition of my employment and upon pain of discipline/termination. I demand a representative/attorney be present before proceeding with any interview or writing any report. I hereby invoke my rights under Garrity v. New Jersey, 385 U.S. 493 (1967) and Spevack v. Klien, 385 U.S. 551 (1956).

It is my belief and understanding that this report/statement is for internal purposes and will not and cannot be used against me in any subsequent proceeding.

\*Statement of Ptl. Kyle Balthis\*

On 12/31/2024 at 0252 hours I was dispatched to S. Main St. Marathon in reference to a male that had attempted to steal a vehicle in the parking lot of the store. Dispatch described the suspect to have a "puffer" coat on and jeans.

I arrived on scene and observed the caller, identified as Errin Johnson, standing in the parking lot near the front entrance of Marathon. While speaking with Johnson, he advised that he had parked his vehicle on the south lot of the store and entered inside to make a purchase. Johnson then stated that he then observed a male, later identified as Moses Alik, enter his vehicle in the driver seat. Johnson stated that he confronted Alik to exit his vehicle and Johnson also stated that Alik was acting very strange. Johnson believed the male was under the influence of drugs and/or alcohol. Alik then exited his vehicle and walked away from the parking lot.

I then collected contact information from Johnson and asked him if he wished to pursue charges for vehicle trespass. Johnson did request that charges were filed.

I then spoke with Marathon employee's who advised they had video footage of the incident.

I then walked with the Marathon employees behind the main counter and observed the security footage. While viewing the footage, Marathon employees had a live feed of the north west parking lot that showed Alik. Marathon employees were advising me that Alik was outside the store currently to north/northwest. Alik was wearing a puffer coat and matched the description of the suspect that had attempted to steal the vehicle.

While I was viewing the security footage, I observed Alik to have a large knife in his hand and he was holding the knife to his neck. At this time I advised Sgt. Crosby that Alik was in the back parking lot of the store and he did have a knife on his person. Sgt. Crosby advised he was arriving on scene after I radioed the information to him about Alik's location.

I then exited the store and drew my firearm and walked to the north east corner of the business. As I turned the corner, I was able to observe Alik standing in the parking lot with the knife in his hand. I then observed Alik start to stab himself several times in the left neck area with the knife. I immediately began to order Alik to drop the the knife.

At this time I also advised Sgt. Crosby who was in the alleyway to the west of the business that Alik was stabbing himself.

I also observed Deputy Heinl with the Mercer County Sheriff Office, arrive on scene from the south west of the parking lot.

I then continued to move towards Alik and continually gave him orders to drop the knife. Alik continued to refuse to drop the knife.

I observed Sqt. Crosby unholster his taser and advise Alik that he needed to get on the ground or

he would be tased.

I also observed that Deputy Heinl had his firearm drawn and that we were in line with one another. I then advised Deputy Heinl to move to the left of me so that we would not fire on one another if lethal force was needed.

Alik then began to move frantically and refused to drop the knife after being ordered multiple times by all officers on scene.

Sgt. Crosby then deployed his taser and appeared to have struck Alik with at least one probe causing Alik to drop the knife. I then started to move forward towards Alik to possibly retrieve the knife or tackle him away from the knife. While I was moving towards Alik, I screamed at him "don't pick it up." I screamed this to Alik due to him reaching down to grab the knife after he had dropped it.

Alik then again picked up the knife and then turned towards Deputy Heinl. I then observed Alik raise the knife above his head and advance towards Deputy Heinl.

As I was moving to the left, Deputy Heinl then discharged his firearm and I believed at the time the firearm had been discharged 3 to 4 times.

Alik immediately fell to the ground and Deputy Heinl, Sgt. Crosby, and I immediately moved in to handcuff Alik.

I then moved forward and grabbed the knife and threw it to my right away from Alik. Sgt. Crosby and I then handcuffed Alik and I then asked Deputy HeinI to retrieve his medical kit from his cruiser.

I was able to retrieve latex gloves from Sgt. Crosby's glove pouch and roll Alik over to his back so that I could assess his injuries.

I was immediately able to observe a large amount of blood on the left hip of Alik. I was then able to place pressure on the wound on the left hip of Alik. While holding pressure on his left hip, I also observed blood emitting from the chest and face of Alik. After pulling up the shirt and coat of Alik, I observed a wound on the upper left chest near the heart of Alik. After wiping the blood away from the chest of Alik I was able to confirm a qunshot wound on the left chest of Alik.

I then advised Sgt. Crosby to retrieve a chest seal bandage from the medical kit and continued to wipe the blood away from the chest wound.

While Sgt. Crosby and I were providing medical attention to Alik, Sgt. Crosby and Deputy Heinl had contacted dispatch to send a squad to the scene to transport Alik.

Sgt. Crosby was then able to place the chest seal on Alik on his chest wound. I also observed several stab wounds on the left neck of Alik while assessing him.

Squad members then arrived on scene and they were advised of the injuries that I had located on Alik.

Alik was then sat up and had his coat removed from him and had his handcuffs removed so that squad members could render aid.

Alik was then lifted onto a cot and placed in the back of the ambulance.

I then entered the ambulance with Sgt. Crosby and assisted squad members. Alik was still slightly resisting officers and squad members while in the squad. I was then able to hear Alik make statements in reference "I want to die" or "kill me."

Alik then slowly started to stop resisting and appeared to either fall asleep or stop breathing. I then

exited the squad due to EMS members no longer needing assistance.

After exiting the squad, I then assisted with securing the scene and standing by the scene.

Several officers from multiple agencies then arrived on scene to assist.

I then stood by on scene as Chief Wale arrived on scene and was eventually relieved from the scene by Chief Wale and returned to the police station.

Statement of Det. Brian Taylor

On 12/31/24 at around 0330 hours, I was off duty when I received a call from Sgt. Pat Crosby. He informed me that there was a deputy from MCSO involved in a shooting in Celina and that the suspect was transported to Mercer Health Hospital in Coldwater. Sgt. Crosby requested that I go to the hospital and follow up with the suspect.

At around 0412 hours, I arrived at the hospital and went to the ER. I was told by the ER staff that the male suspect was deceased and they directed me to the room where the male was. I went to the this room and observed a Marshallese male deceased in the room lying on his back. I observed that he had a wound to his chest, one wound to his right leg, one wound on his upper left thigh and one wound to the left side of his neck. It appeared to me that the wound on his neck was caused from a knife or some type of sharp and pointed object. Coldwater officer Jason Miller was also present in the ER. He informed me that the officers at the scene possibly believe the deceased male was 22 year old Moses Alik of Celina. However, no one at the time could confirm the male's identity.

I then contacted Chief Deputy Doug Timmerman at MCSO to inquire about the investigation. He told me that BCI&I was contacted and that they were enroute to investigate the shooting.

I eventually cleared the hospital after Ptl. Miller agreed to stay with the body until an agent from BCI&I arrived. I arrived in the area of the shooting scene, which was the Marathon station at the corner of S. Main St. and W. Warren St. I met with agent Doug Burke from BCI&I. He requested assistance from both Det. Poppe and myself. Agent Burke wanted me to make death notification to the family of the suspect. I was provided a name, Roselee, and a phone number for a cousin of Moses Alik.

Det. Carla Bacher from MCSO eventually met with me at the scene and we traveled to 1400 W. Market St. Apt. #4 and made contact with 29 year old Roselee Akilang. She confirmed that Moses was her cousin and that he stays at her apartment occasionally. I explained to her that there was a deceased male at the hospital that possibly was Moses. I told Roselee of some of the tattoos that the male had. She confirmed that Moses did have similar tattoos. I asked Roselee if she would go with us to the hospital to confirm the identity of the deceased male. Roselee agreed too.

We then transported Roselee to the hospital. While enroute there, Roselee did tell us that Moses does have a alcohol problem and has mental health issues.

After arriving at the hospital, we went to the ER room where the deceased male was. Roselee confirmed that the male was Moses Alik.

We eventually cleared the hospital after Roselee confirmed Moses identity and we transported her

back to her apartment, where we dropped her off at. Two agents from BCI&I also arrived at the apartment to follow up with Roselee and her family. We then cleared this apartment.

#### Investigative Notes

On December 31, 2024 I was contacted by Captain Baker and briefed about an officer involved shooting. I was asked to come into work in uniform to secure the scene with a marked patrol cruiser. I arrived at the scene at around 0709 hours and parked my cruiser on W. Warren St. at Main St. with another Celina PD unit. I shortly after moved my cruiser to W. Warren St. and S. Walnut St. blocking the roadway as the OSP unit at that located needed to clear. Detective Baucher later parked her unmarked vehicle with lights at this location and I moved up to where Chief Deputy Emerine had parked as he cleared the scene. I remained at this located and after BCI completed their on scene investigation I was advised that I could collect Deputy Spencer Heinl's EMR kit, EMR bag, and other property left behind that BCI was not collecting as evidence. I notified Celina PD Sgt. Fuelling that BCI had completed their on scene investigation and we could start working on taking down the perimeter that was established. I photographed and collected the property left behind being an EMR box kit, EMR black bag, black bag with medical gloves, set of handcuffs, black handcuff key, black small flashlight, car charger, and USB cord. I helped take down the perimeter caution tape and when all opened back up I cleared the scene with the other units. Deputy Heinl's patrol car was brought back to our office and parked in our storage building. I brought into our office Deputy Heinl's property to allow it to dry off. My body cam was not activated at anytime. No further notes.

#### SUPPLEMENTAL

On 12/31/2024, I was on station past my scheduled end time of 0000 hours due to finishing notes for an unrelated report. Once these were complete, I was in Dispatch prior to going home. While in there, I copied radio traffic that Deputy S Heinl was out with Celina PD units and a male at Marathon in Celina, though I did not know what they were out there for at the time. A few moments later, I copied radio traffic from Deputy S Heinl, who advised that there were shots fired. I then ran to my patrol cruiser and responded to Marathon with my emergency lights and sirens activated. While en route, I further copied radio traffic from Dispatch, who was asking if anyone was hit, but no one responded. I then copied that Deputy S Heinl was requesting a squad and that Dispatch was already getting one en route. I also copied radio traffic from Deputy S Heinl advising Sqt Etgen, who was already responding behind me, that he needed to respond as well.

Once I arrived on scene, I observed a Celina PD cruiser parked facing South in front of the front entry doors of the gas station, but observed that that Deputy S Heinl and Celina PD officers were in the parking lot on the Northwest side of the gas station kneeling over someone on the ground. I parked my patrol cruiser to the East of them facing the gas station. I exited my patrol cruiser and, upon approach, observed that Celina PD Officer Balthis and Sgt Crosby were kneeling over a Marshallese male, who was on his back with his hands cuffed behind him, and rendering aid to him. At that time, Deputy S Heinl was standing to the South of them and I observed that no officers appeared to have been shot or injured. I observed that the male on the ground had been tased and was breathing heavy. I also observed that he was bleeding from a wound on his chest with a chest seal over it. I learned that the officers had placed the chest seal on the wound while rendering aid prior to my arrival. I further observed that the male was also bleeding from another wound, which was on his lower left torso/hip area, which Officer Balthis was applying pressure to. These wounds looked to me to be consistent with bullet wounds.

I put a pair of blue sterile gloves on and was asked to hold a flashlight so the Celina PD officers and the Fire/EMS personnel, who arrived on scene just after me, could see better while they continued to render aid to the male. The male's coat was cut off of him while rendering aid and I helped to remove his left sleeve from his arm, as the sleeve was stuck. When they were ready to lift him onto the cot to put him in the waiting ambulance, I helped grab one of his legs to lift him onto the cot. Once he was in the ambulance, I helped Coldwater PD officers Griesdorn and Diller, who had later arrived to assist, put crime scene tape around the area. I remained outside of the crime scene tape on the North side to ensure that no unauthorized persons entered the area. The Coldwater officers, more Celina PD officers, Ohio State Highway Patrol troopers, Auglaize County Sheriff's deputies, and St Marys PD officers all secured the area from different positions as well when they each arrived. The ambulance remained on scene for a short while before leaving the scene with the male with their emergency lights and sirens on. To my knowledge, crime scene tape was only moved to let the ambulance leave and to secure the tape better by using nearby traffic cones.

While keeping the area secure, a van with two Marshallese females inside pulled up to me. They showed me an Ohio ID and asked me if the kid in the ambulance was him. I looked at the picture and observed that it appeared to be the male I had seen on the ground. I did not advise them of this, but did advise them that I was not sure. I advised them to wait here while I checked with someone who might be able to help more. As I was not sure what information could be released at that time and was not involved in the situation, I advised Officer Balthis, who was keeping the scene secure from inside the crime scene tape right behind me, that I believe the male's family is here. I asked him what he wanted me to tell them or where to advise them to go. He advised to have them park on Walnut Street near the stop sign and let them know that someone would be coming to speak with them soon. I then advised them the same and they did so without issue. This information was passed on to Captain Baker when she arrived a short while later.

I continued to keep the scene secure and, at one point, was advised by a trooper that there was a male witness nearby that lives across the street and had seen the whole thing happen. I was advised that it had something to do with a vehicle the male had been trying to break into. I had him pass this information along to Captain Baker, as he was going over to her location to speak with her anyway.

Once BCI arrived and it was determined that my patrol cruiser could not be moved due to it being inside of the taped-off area, I was advised by Chief Deputy Emerine, who had also arrived on scene, that Sgt Fink would be en route to relieve me and drop me off at home to end my shift. Once Sqt Fink arrived, he dropped me off at home and my patrol cruiser was later returned to me.

My bodycam was active when I first arrived and was also active at times while keeping the perimeter secure.

#### SUPPLEMENTAL NOTES

On December 31, 2024, I received a call from Captain Baker at home. She requested that I respond to the Marathon on South Main Street in Celina and very briefly explained what was going on. She asked that, once on scene, I take Deputy Nixon home, as she was past her scheduled shift, and then respond back to the scene to assist in securing it. I then did the same. After taking Deputy Nixon home, I parked my cruiser at the southwest part of the scene in the alley to relieve an Auglaize County unit and I stood by with Chief Deputy Emerine and secured the northwest part of the scene on the outer part of the police tape. After Chief Deputy Emerine left, I had Detective Wuebker replace his vehicle and I went back to the southwest part of the scene near the alley. After BCI&I was complete with their investigation, I assisted in taking down the police tape. Detective Wuebker and I then relayed Deputy Nixon's cruiser back to her residence and Deputy Heinl's cruiser back to our evidence garage. I then returned to patrol.

My body camera was not activated on scene due to just securing the scene. My cruiser camera footage has been added to this report.

#### INVESTIGATIVE NOTES- DEATH NOTIFICATION

On 12/31/2024 I was contacted by Captain Baker on my way into work and briefed on an officer involved shooting, and that BCI would be conducting the investigation. After being at work for a little while, I was instructed to meet up with Detective Taylor with Celina PD to assist in completing a death notification but that we were still attempting to confirm the identity of the deceased male. I was provided with a business card for the BCI investigator, and told to provide it to the family while delivering the message.

I then called Det. Taylor to find out where he wanted to meet as I was told he may be at the hospital or at his station. I was advised he was on the scene and asked to meet him there. I then parked on the west side of the scene and walked to Det. Taylor's car. From there we began discussing the family member and what was done in order to identify the deceased male. I was told that we believe the subject was Moses Alik, and that Det. Taylor had been to the hospital and photographed his injuries and noticed some tattoos, he thought he was told by hospital staff that Moses' identity was confirmed based upon a tattoo on his neck. We then received a call from BCI investigator Doug Burke, who advised to hold off on the notification until we can confirm the identity better. Chief Deputy Emerine then joined us in Det. Taylor's car and several more phone calls were made. We discussed getting tattoo or book in photos of Moses to take to the hospital to try to confirm that way. It was ultimately decided that we would make contact with Moses's family member who had showed up on scene shortly after the shooting and provided her information and Moses' ID to a OSHP trooper, but had since left, and we would see if she could come with Det. Taylor and I to the hospital to attempt to identify Moses.

Det. Taylor had already contacted Roselee as it was the phone number she had left with the trooper, and told her we would be coming. Once at Roselee's residence at 1400 W Market St. Apt. 4, we made contact with Roselee Akilang and her boyfriend Jite Marshall. We asked Roselee what her relationship was to Moses, in which she corrected us stating that she was his cousin not his aunt. She stated that her Aunt Jerrylee, her grandmother, her mother, and disabled sister all reside in different apartments in Williamsburg Square. She stated that he would be able to identify Moses if it were him and was willing to go with us. She confirmed that she had shown up on scene after getting a call from one of Moses's cousins who resides near the Marathon stating that Moses had shown up at his house not making sense and hallucinating, shortly after that they seen police officers all arrive in the area, she did not see Moses, but provided his ID to the trooper.

Roselee was able to confirm with Det. Taylor that Moses had "Thug Life" tattooed across his knuckles, as well as "RIP or RIT" tattooed near his thumb, and a large tattoo on the back of his calf. We then asked about his other family members. She told us that his mother is in Maui, Hawaii, and his father is in Everette, Washington. She was not sure what Moses' mother's name was, thought it was Elizabeth, but was not sure, she said his father's name was Gibson Alik. She also did not have phone numbers for either of them. She told us that Moses typically chills on her couch and stays there or her auntie's house. He was there last night and she did not think he was drinking, but she knows that he drinks a lot a he had recently been fired from his job at Basic Grain for being drunk. We asked Roselee if she would be willing and able to do the notification or if she would rather us reach out to a different family member. Roselee said that she would be the best one for it, worried about how to even tell her grandmother about this.

While Roselee was changing clothing to come with us to the hospital, I stepped out to answer some phone calls that had come in while Det. Taylor and I were speaking with Roselee, there was some question over where Moses' ID was that Roselee had provided to the trooper. I advised that Roselee told us she gave it to the trooper, however once Roselee changed and got into the car with us, she then told us that she took the ID back and now had it on her. She provided that ID to Detective Taylor on the way to the hospital.

Once we were at the hospital Roselee was prepared for what she might see, being the medical intervention and that he had a tube down his throat. We then brought Roselee into the room and she immediately identified his mas Moses. She then took a call from her Aunt Jerrylee, who requested to come to the hospital to see him as well. I spoke with the Aunt on the phone and told her that unfortunately due to the circumstances of an ongoing investigation she was not able to view him now as he would be sent for an autopsy. I notified Lt. Hamberg who had been trying to locate photos from our jail to help with the ID process that Roselee identified him as Moses Alik, and provided us with his ID. I also advised this same information to Agent Burke and Captain Baker. Once that was completed then the family would get him back and they could view him. I asked Jerrylee if she knew what funeral home the family would use and she did not know, Roselee stated that they would use Cisco as that is who has handled the rest of things. Roselee noticed that Moses had a chain around his neck and asked for it. We told her that he had to stay as is for now, but that we would be able to hopefully get his belongings such as his chain back to her after the autopsy.

We then left the hospital, when we exited the ER she ran into other family members that were there for an entire different reason. I then asked her if she was wanting to go with them or if we could bring her home, she then requested that we bring her home. While on the way home,

Roselee was asked again if she wanted help notifying the rest of her family but she again denied stating that she would be able to do it. We thanked her for being strong and able to identify Moses and we were sorry for her loss. She had several questions and I tried to explain to her the best that I could that there was a shooting that had occurred and our agencies were involved, so there is an independent investigation being completed by BCI per our request. I provided her with the BCI Agent's card and explained to her that her information would be passed on to them as they would like to come and speak with her, and hopefully they would be able to provide her with more information. We also advised her that they may not give a bunch of information as it is an investigation, but once it was completed she, like our agency, would receive a full report. She seemed to understand this. I then asked her how she was doing, and she replied that she was just angry. She was angry at Moses, elaborating that she told him he needed to clean his act up. She said that he was in all sorts of trouble in Maui, and had spent some time in Prison there for robbery and maybe stealing a car. She said that once he got out he was sent to his dad to try to straighten things out in Washington, and then he came over here as he was close to his cousins, on his dad's side. She said that she didn't feel that he was trying to get better. She did not know of him using any other drugs other than some marijuana and drinking, but knew him to hallucinate. She said that he had told her that he would have to get clean before he could apply for another job, but she didn't know what he needed to get clean from.

We then arrived at her apartment and told her she could go inside, but that BCI agents were getting ready to come to her house to speak with her if she was up for it, she said that would be fine and we can just knock and she will answer the door.

While we waited for BCI Agents to meet with us, Jerrylee arrived at Roselee's apartment and wanted to talk. I again apologized that I would not allow her to go to the hospital to see Moses yet, but explained some of the surrounding protocols. She, like Roselee asked how he got shot. I explained to her that it is an ongoing investigation, and that our office is involved in it so I do not know the details of everything, but that the BCI agents arriving will have more information for her but I was unsure of how much they are able to release at this time. She seemed to understand that and went inside with Roselee.

Det. Taylor and I stood by until BCI agent Ryan arrived and he was provided with the information we had gather from Roselee. He then asked that we wait until Agent Burke arrived and once he did, he was provided with Moses's ID and we were no longer needed so we left.

I returned back to my car on scene, and assisted in removing some of the road barricades once the scene was being cleared.
