

#### Alliance, Ohio

Agent Lulla was advised that earlier in the day, Alliance Police responded to the residence where they observed George W. Appleby (C/M 5-12-64) apparently hold a large knife to the throat of (C/F 3-11-55). Apparently, Appleby forced into the apartment and eventually into a bedroom which has its door locked from the inside. As Alliance officers forced their way into the bedroom, Appleby was found to still be holding the knife to striking and at this time an Alliance Patrol Officer fired two shots from a patrol rifle, striking Appleby in the head and killing him.

At this time, the BCI Special Agents were informed by Alliance Police Investigators that that the County Prosecutors Office had been notified and it was their legal opinion that a search warrant for the residence would not be needed, however, a consent to search from was obtained from whose apartment the shooting had taken place inside of.

Prior to any crime scene processing, photographic documentation of the scene was obtained followed by a laser scan using a Leica RTC 360 Laser Scanner.

A search of the scene revealed an older Caucasian male in the apartment's bedroom just right of the bedroom door. The subject (George W. Appleby) was deceased and had severe trauma to his head. The subject was discovered to be supine and was found to be wearing only a pair of shorts.






