**Narrative:**

On Monday September 8, 2025, at approximately 2000 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) responded to the Ashtabula County Sheriff's Office (ACSO) to meet with the involved deputies from the officer involved shooting incident.

The involved deputies [REDACTED] had been separated from one another at the ACSO, prior to SA Lamping's arrival. SA Lamping spoke with each deputy and informed them that BCI had been requested to investigate the incident. Each deputy was asked if they would like to provide a statement. They all declined and advised that they were being represented by the Ohio Patrolman Benevolent Association (OPBA). SA Dan Boerner (SA Boerner) collected each deputies' firearm, along with [REDACTED]  
[REDACTED] Taser X-26P that was later released to the agency after the data from it was downloaded.




