Narrative:

On Thursday, August 24, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Russell (SA Russell) and SA James Mulford (SA Mulford) interviewed Kyra Williams (Williams), relative to the officer-involved shooting which took place on Wednesday, August 23, 2023, in the area of 1389 Marion Drive. The interview took place in 1389 Apt C, Marion Drive, Columbus, Ohio. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

Williams stated that Jamie Overstreet (Overstreet) called her and wanted to come over as he was having a bad day. Williams added that she and Overstreet possibly have a daughter in common and have been friends for a long time. Williams stated that Overstreet was at her residence the previous night talking about committing suicide. Williams added that she saw Overstreet with a little blue gun laying on her bed, next to him. Williams stated that Overstreet hung out for a bit then left. Williams added that Overstreet called her the next evening around 10:30pm and told her he was heading over to her place. Williams added that Overstreet was depressed due to "baby mommas" and his ex-wife.

Williams Stated she heard gunshots in the area, looked out her patio window and saw Officers handcuffing a subject behind her residence by the courtyard. Williams did not know that it was Overstreet, until she saw the gun laying on the sidewalk that she had seen the previous night on her bed with Overstreet.

Williams stated that Overstreet lives on Hempstead somewhere, drives a small black Monte Carlo with a sunroof and is the general manager of Jimmy John's in Upper
