On March 30, 2026, at approximately 1200 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by Captain John Thompson of the Harrison County Sheriff's Office (HCSO) to conduct an independent investigation of the facts and circumstances surrounding multiple (three) officer-involved critical incidents which occurred in Harrison County, Ohio, on March 30, 2026.

Special Agent Tingley (SA Tingley) responded to assist, arriving at approximately 1300 hours. Also responding from the BCI North Force Investigations Unit were Special Agents Goudy, Boerner, Bynum, Lamping and Special Agent Supervisor Charles Moran. Additionally, the BCI Crime Scene Unit was requested to process multiple scenes by documenting and collecting pertinent evidence.

The shooting incidents involved a subject, Michael Decker, and members of the HCSO, the Ohio State Highway Patrol, and the Cadiz Police Department. The incident resulted in the death of Decker.
