NARRATIVE

******CRISIS INTERVENTION REPORT******

On April 16th, 2022. While assigned the 5th District as 5A11, I (P.O. Glass #332) accompanied by P.O. Elkhatib #120 received a radio broadcast c/w possible bomb threat. Below are the details.

Upon our arrival, The original caller/ a male carrier was not on scene. However, we were met by Robert Perkins (victim). Robert was working on setting up lights on his front porch. I conferred with Robert briefly and eventually told Robert the reason we were on scene. Robert stated he does suffer from Autism and Tourettes syndrome. Robert stated he served in the army and was on the bomb squad and that he might have been shouting because of his Tourettes. Robert stated she doesn't suffer or take any medicine from any mental illness.

Furthermore Robert stated he doesn't want to hurt him self or anybody at this time. Robert agree to let P.O. Elkhatib#120 and I search his property including his Garage and vehicle. Nothing was found. Sgt Bays #9300 was also on scene and found evidence of a Bomb or Bomb threats.
