Narrative:

On May 6, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) obtained a search warrant for the vehicle (1994 Chevy Pickup Truck) that Kendell Woodard (Woodard) occupied during the incident.

Once the search warrant was obtained, SA Momchilov made contact with BCI Crime Scene Agent Larry Hootman (Hootman). SA Hootman was at Rosenberry Towing, 1447 OH-39 NE, New Philadelphia, Ohio, the location of the 1994 Chevy Pickup Truck. SA Momchilov advised SA Hootman, that the search warrant had been obtained, and the search of the vehicle could commence.

A short time later, SA Momchilov arrived at Rosenberry Towing and made contact with SA Hootman and SA Chad Doran (Doran). SA Hootman and Doran processed the vehicle. The following items of potential evidence were collected:

SA Momchilov then transported the obtained items to the Richfield Office of Ohio BCI and placed the items into Temporary Evidence Locker #4 at 1831 hours.

Item #45 "Envelope containing wallet" contained cash.

On May 7, 2024, SA Momchilov and Administrative Professional Betty Farris counted the cash and determined that the wallet contained \$62.00 (3-\$20.00, 2-\$1.00). A Monetary Evidence Receipt was completed.
