DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for the Board of Trustees, Miami University, Oxford, Ohio, and the Hamilton Electric Company of Hamilton, Ohio. This contract covers the construction and completion of contract for electrical connections to Chemistry Building, and Physical Education Building, as set forth in Item No. 6 of the Form of Proposal dated December 20, 1930. Said contract calls for an expenditure of three thousand eight hundred and seventy-five dollars (\$3,875.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. You have also shown that the Controlling Board has consented to the expenditure in accordance with Section 11 of House Bill 510 of the 88th General Assembly. An affidavit of the auditor of Butler County shows that the two sureties have property sufficient to cover the contract price.
