Narrative:

On Wednesday, September 29, 2021, at 1112 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Shane Hanshaw (Hanshaw) interviewed Tenaya Young (Young), relative to an Officer Involved Critical Incident (OICI) in the form of an officer-involved shooting which took place on Wednesday, September 29, 2021. The interview took place near 2469 Kimberly Pkwy. E, in Columbus. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

This report only summarizes the information deemed by the author to be of the most relevance to the investigation and does not purport to contain all questions and answers from the interview. Further, this report was placed in a chronology to aid the reader's overall understanding of the information obtained during the interview and may not be reflective of the actual sequencing of questions. It is suggested that the full recording be reviewed to clarify any content or contextual questions regarding the information from the interview.

At the time of the incident, Young was parked on the parking lot of the Thrift store located across from the location of the incident. Young and her mother-in-law, Isabella Akins (Akins) were in the Thrift store parking lot, waiting for the store to open. Young is not familiar with any of the involved civilians or police officers. Young did not record or take any photographs at the time of the incident. Young's phone number is (614) 805-0583.

At the onset of the interview, SA Hanshaw identified himself and gave his background and roll in the investigation. SA Hanshaw asked Young if he could record the interview and Young agreed to the recorded interview.

Young stated she and Akins went to the Thrift store to purchase some items. Young said she arrived at approximately 0939 hours. Upon arrival, Young said the Thrift store was closed and

she was told that it would open in about twenty (20) minutes.

Young said she returned to her vehicle, a silver 2017 Chevy Malibu, intending to wait for the store to open. Young said as she was waiting, she heard three (3) gunshots. Young said she saw a female running between two apartments and a male running in the street.

Young said after hearing the shots she pulled out of the parking lot toward the direction of the apartments, and saw officers doing CPR on a man that was lying in the road. Young said it could not have been more than a minute from the time she heard the gunshots to the time she saw the officers doing CPR. Young said another car was sitting in the intersection in front of her, so she pulled around the car and left the area.

Young said she and Akins traveled back to Akins residence. Young said when she arrived at Akins residence, she fed her son, and then returned to the Thrift store with Akins. While at the Thrift store, Young said she and Akins were approached by a police officer and asked if she had witnessed the incident. Young said the officer told her that she would have to stay at the scene and give a statement to investigators regarding what she had witnessed. Young said she told the officer that she did not want to stay and the officer told her he would have to detain her the scene until she was interviewed.

The interview concluded at approximately 1126 hours.
