Narrative:

On Tuesday, June 24, 2025, the Brooklyn Police Department (BPD) requested Bureau of Criminal Investigation (BCI) assistance at the scene of an officer-involved critical incident at the Tiedeman Rd. and I-480 westbound on ramp in Brooklyn, Ohio. As part of that investigation, Special Agent (SA) Joe Lamping (SA Lamping) was requested to attend the post-mortem examination of the decedent. The examination was conducted on June 25, 2025, at the Cuyahoga County Medical Examiner's Office in Cleveland, Ohio.

On Tuesday, July 8, 2025, at approximately 10:27 hours, the following items of evidence were collected and transferred to the custody of SA Dan Boerner (SA Boerner) by Megan Gates of the Cuyahoga County Regional Forensic Science Laboratory (CCFSL):

1. One swab from under the fingernails of the right hand.
2. One swab from under the fingernails of the left hand.
3. Two swabs from the knuckles and palm of the right hand.
4. Two swabs from the knuckles and palm of the left hand.
5. One pair of gray pants.
6. One black belt (packaged with gray pants).
7. One black sock.
8. One black sock
9. One right white shoe.
10. One left white shoe.
11. A sample of head hair.
12. A sample of beard hair.
13. Projectile fragments from torso.
14. Portion of buccal swabs for release.

The items of clothing were photographed and examined for items of suspected evidence and no items of suspected evidence were observed (*Figures 1-7, Clothing*). The items of evidence were subsequently transferred to Administrative Professional Betsy Turney (AP Turney) for entry into Matrix/evidence. The evidence transfer sheet documenting the exchange is attached to this investigative report.

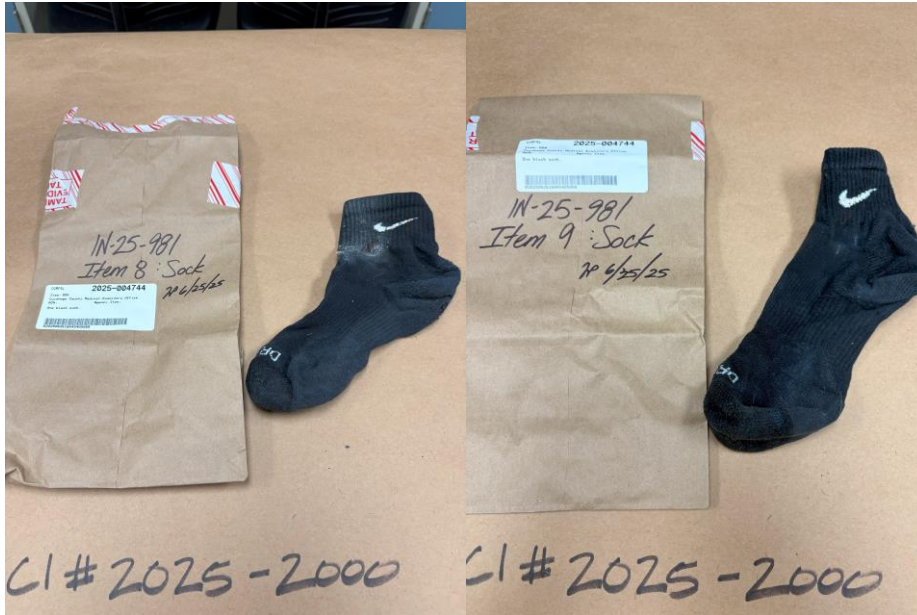

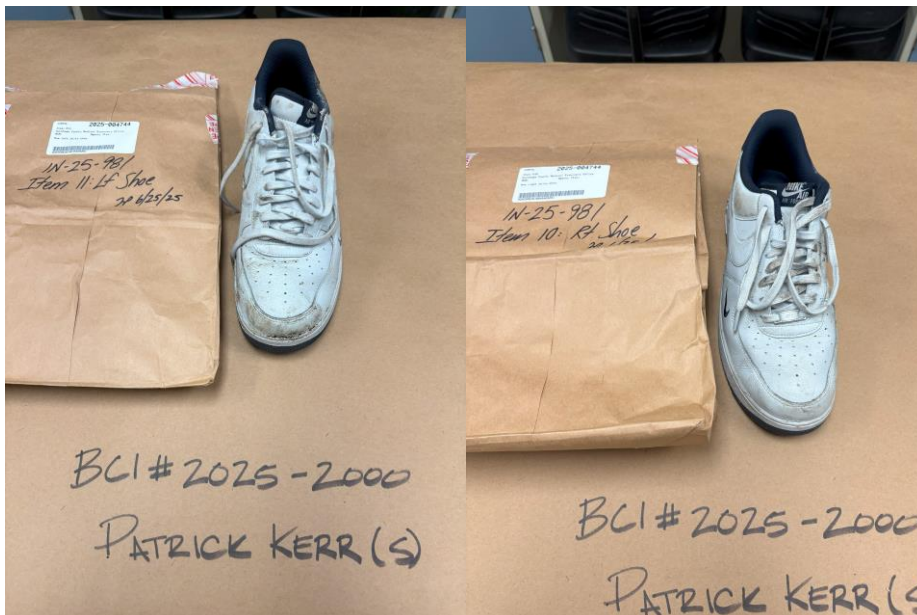

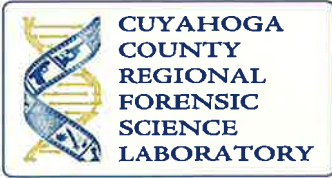
