Narrative:

On Tuesday, January 09, 2024 at 2354 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chad Holcomb (SA Holcomb) and SA Andrew Russell (SA Russell) interviewed Ron Gullett (Gullett), relative to the officer-involved shooting which took place on Tuesday, January 9, 2024. The interview took place at 9714 State Route 93, Pedro, Ohio. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

SA Holcomb and SA Russell introduced themselves to Gullett and asked if he would be willing to talk to the agents; he said he would talk. Gullett stated that he and his sister, Donna Gullett, live at the residence. Gullett stated that he worked today and got home around 4pm and was inside the residence when the incident took place but doesn't know what happened.

Gullett was asked if he knew Skyler Corbin (Corbin) and stated that he was Peanut's (later identified as Maralynda Wilburn) son. He was not sure why Corbin would've been at the residence that day and couldn't recall if he was ever inside the residence that day. He was asked how he knew [REDACTED] and stated that she might be the one who lived with or worked with his sister; he was unsure. Gullett thinks that [REDACTED] and maybe Corbin came into the house that day but was unsure.

Gullett said that a deputy knocked on the door while he was asleep on the couch, but he wasn't sure who he was. He never heard any yelling or gunshots while he was inside but thinks he was asleep.

The interview concluded at approximately 0004 hours.

Agent note: Gullett seemed extremely confused throughout the interview.
