#### Narrative:

On Saturday, June 01, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agents Eric Lehnhart (SA Lehnhart) and Andrew Harasimchuk (SA Harasimchuk) conducted a neighborhood canvass in the area of 2212 Tryon Road, Ashtabula, Ohio 44004, Ohio. The purpose for the canvass was to identify and interview potential witnesses to the officer–involved critical incident shooting that occurred at 2212 Tryon Road, Ashtabula, Ohio 44004, Ohio on Saturday, June 01, 2024. During the neighborhood canvass, Special Agents Lehnhart and Harasimchuk made or attempted contact with the residents at the following addresses:

### 2108 Tryon Road, Ashtabula, Ohio 44004

Debra and Claude Noah advised agents that they were home at the time of the incident with John Perry. Ms. Noah stated that she was in her sewing room at the southwest corner of their home and witnessed what she believed was a traffic stop around 2000 hours. she continued to state that she didn't not see the actual event take place but did hear officers make attempts to communicate with the subject through a bullhorn or PA system. She stated that she could hear officers tell the subject that he needed to "turn himself in" and they could get him the help he needed. The couple did hear what they called a "popping" noise but couldn't identify what made those noises. Other information that the Noah's provided was hearsay from their neighbors.

#### 2103 Tryon Road, Ashtabula, Ohio 44004

Ester Rose advised agents that she had surgery on Friday, May 31, 2024, and was not up at the time of the actual critical incident shooting. However, earlier in the evening, she and her husband John Rose, a retired Park Ranger, heard what they believed to be two (2) flash bangs detonating.

Trina Shell advised agents that she and her family were not a home at the time of the incident. According to Shell, they tried to come home the evening before but were turned away as law enforcement had the roadway blocked off prior to their residence.

## 2313 Tryon Road, Ashtabula, Ohio 44004

There was no answer at this residence.

The neighborhood canvass interviews conducted were video recorded utilizing SA Lehnhart's Axon Body Worn Camera (BWC). A copy of the recordings was placed onto CDs which are maintained in the physical case file as an item for reference only.
