## Narrative:

On October 8, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested to investigate an Officer-Involved Critical Incident (OICI) that occurred at 6463 Tara Brooke Court, Hamilton, Ohio, which resulted in the death of Stephaun Jones.

BCI Special Agents (SA) Lauren Frazier and Doug Eveslage interviewed Greg Reagan (Reagan), who resides at 6383 Tara Brooke Court, Hamilton, Ohio.

The details below summarize the pertinent portions of the recorded interview. Please refer to the audio recording for additional information.

The interview with Reagan began at 0016 hours on October 9, 2022, at the scene location, 6463 Tara Brooke Court, Hamilton, Ohio.

Reagan stated that he arrived home at approximately 1930 hours on October 8, 2022. He said that he saw two officers at the end of the street looking around and his wife told him what was going on.

He said that he was trying to sell a car, which was parked partially in his garage, when a male subject walked up and into his front yard. Reagan stated the male asked him how to get to "Lindenwald." Reagan described that he looked out of place in the neighborhood, and described that he had dreadlocks and was wearing a camo sweatshirt. He said that the male's hands were out while he was talking to him and he did not observe him with a firearm. Reagan stated that the male appeared to be "under the influence" based on his behavior.

Reagan gave the male directions, but he stated that he kept hanging around and that it appeared that he was "sizing him up." Eventually, the male left and Reagan located the two Hamilton police officers down the street and told them where the male was headed.

Reagan described that the officers were armed with rifles, had their spotlights on and doors open, while they were looking for the subject. Reagan stated that approximately two minutes later, he heard "loud talking" between the officers and subject for approximately one minute and then heard four gunshots.

Reagan said that he does not have any cameras at his residence, but his neighbors across the street might.

The interview concluded at 0020 hours. A copy of the audio recording is attached to this incident.
