DEAR SIR: You have submitted for my examination and approval a reservoir land lease in triplicate executed by you as Conservation Commissioner to one C. M. Boyer of Bucyrus, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$18.00, payable in semiannual installments of \$9.00 each, there is leased and demised to the lessee above named, the right to occupy and use for cottage site and docklanding purposes, that portion of the westerly embankment of Buckeye Lake that is included in the inner slope and waterfront and the outer slope and borrow pit adjacent thereto that is included in the south half of Embankment Lot No. 34, south of Lakeside, as laid out by the Ohio Canal Commission in 1905, and being part of the Northeast Quarter of Section 28, Town 17, Range 18, Fairfield County, Ohio, and being a renewal of a certain leasehold granted by the State of Ohio to George Boyer of Bucyrus, Ohio, by lease dated December 12, 1905.

DEAR SIR: You have submitted for my examination and approval a reservoir land lease in triplicate executed by you as Conservation Commissioner to one Mary L. Kaiser of Columbus, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$18.00, payable in semi-annual installments of \$9.00 each, there is leased and demised to the lessee above named, the right to occupy and use for cottage site and landing purposes, the inner slope and waterfront and the outer slope and borrow pits in the rear thereof that is included in the south half of embankment lot No. 17 south of Lakeside, as laid out on the west bank of Buckeye Lake by the Ohio Canal Commission in 1905, and being the same ground that was leased by the State of Ohio to W. H. Stewart by lease dated December 12, 1905. Said half lot has a frontage of 50 feet measured along the top of the outer slope of the reservoir embankment, and is a part of the southwest quarter of Section 21, Town 17, Range 18, Fairfield County, Ohio.
