MEETING MINUTES

June 9, 2025 | 10 A.M. - NOON

I. Welcome and Introductions

- Virtual attendees introduced themselves in the chat and on mic.
- In-person attendees introduced themselves.

II. Ambassador Advisory Council Updates

- The current Ambassador term is ending June 30th.
- We will be honoring graduating at the July 30th Human Trafficking Summit.
- Interviews for new Ambassadors have been completed and selections are in progress! Returning Ambassadors will serve as mentors.
- Comments from Ambassadors:
 - Harold D'Souza: Announced graduation from the Ambassador role; shared updates on the Assisi Free Bread House in Tanzania, which was launched by his organization, Eyes Open International: [Pingara - From Chains to Change: Survivor Family Feeds Hope Across Continents Through Acts of Love](#)
 - Nancy Hashman: Shared that she is excited to return and continue training youth on human trafficking.

III. Subcommittee Updates

A. Healthcare – Lily Holderbaum

- The subcommittee continues to explore avenues for nurses to be required to receive human trafficking training. Discussions have been had with the Ohio Nursing Association (ONA) and a meeting is pending with the Ohio Board of Nursing (OBN) in attempts to gauge potential support and paths forward.
- The group is also working on creating posters for various patient settings.

B. Law Enforcement

- No representatives were present and no updates were given.
- Aaron Dennis will take over as chair of this subcommittee and plans to attend the next quarterly meeting with updates.

C. Legal & Legislative – Linda Majeska Powers (on behalf of Samantha Salamon)

- This subcommittee is partnering with the Healthcare subcommittee to focus on mandating human trafficking training for nurses.

- The group is also considering the possible of landlord engagement as a strategy for combatting illicit massage businesses. They are in the process of gathering templates and discussing potential risks of the displacement of victims.

D. Demand Reduction – Tony Talbott

- Tony reported that scheduling conflicts have limited meetings
- The group continues to work on the white paper draft, which is expected to be completed in 1–2 months

E. Public Awareness – Mary Kate Waggoner (on behalf of Lara Wilken)

- A draft has been completed for the updated ‘Apps to Watch For’ guide
- The group is currently working on updating the online safety resources for parents and caretakers.
- This year, the annual public awareness survey indicated that the Human Trafficking Commission’s trainings reached 9 new counties. The graphic with the full results will be included in the upcoming 2024 Human Trafficking Annual Report.

F. Research, Data & Gap Analysis – Amy Lagesse (on behalf of Kirsti Mouncey)

- The FOCUS Youth screener has expanded to more counties!
The University of Toledo is exploring the possibility of creating a web platform for aggregate ZIP code data.
The subcommittee continues to partner with Dr. Rosario Allen for the FOCUS adult screener validation.

G. Victim Services – Michelle Hannan & Rebekkah O’Bryan

- The subcommittee is beginning the renewal process for organizations that met the Standards of Service for Trafficked Persons back in 2022.
- New documentation is required for agencies that have met the standards, including a support letter and training details.
- A full review of the Standards of Service for Trafficked Persons is scheduled, and a new edition is planned for May 2026.

IV. Human Trafficking Initiative (HTI) Updates – Linda Powers & Mary Kate Waggoner

- HTI is working on onboarding new Ambassadors and introducing them to returning Ambassadors as mentors.
- The Human Trafficking Summit (July 30th) is approved for up to 5 CEUs (counselor, social worker, and marriage & family therapist), CLEs, healthcare

CEs, and CPTs. The keynote speaker is Dr. Alexis Kennedy, who will speak on combatting compassion fatigue and burnout in the anti-trafficking field. Early bird registration closes June 16th; the final deadline to register is July 11th.
