Narrative:

On Monday, September 29, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Lamping (SA Lamping) received requested records and recordings from Ohio State Highway Patrol (OSHP). SA Lamping had previously requested all dispatch records, audio-recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date of the officer involved critical incident (OICI): September 8, 2025. As a result of that request, the following items were received and reviewed:

Radio Traffic Recordings:

The OSHP radio traffic Report documents times personnel were assigned to the call. The report contains the dispatch, en route/arrival times of the officers who responded, to the vehicle pursuit started by the Ashtabula County Sheriff's Office. The radio traffic can be located in Axon Justice - Reference Item F - OHSP Dispatch Recordings. The file can be found under the following title:

 - The file in its entirety is approximately 5 hours and 14 minutes long. The following is what was seen as valuable to the OICI investigation:

On September 8, 2025 at approximately 1332 hours, the Ohio State Highway Patrol (OHSP) was notified of a vehicle pursuit involving Ashtabula County Sheriff's Office. The subject vehicle being pursued was described as a red motorcycle traveling at a high rate of speed. Once OHSP officers were involved with the pursuit, call sign █ advised, "You can monitor it from a distance. Let, that's their pursuit. Just trail it. Do not get involved with it." (10:09 minute mark). During the pursuit, the subject was alleged to be throwing plastic bags from the motorcycle. Speeds ranged from approximately 35 mph to 90 mph. It is unclear through the transmissions if the subject

crashed the motorcycle or purposely laid it down. The subject ended up fleeing on foot and the motorcycle was in flames. Soon after the subject fled on foot, an officer communicated with dispatch that shots had been fired. After the communication that shots were fired, radio transmissions consisted of scene security.

The following transmissions shown in the table are what SA Spann found to have investigatory value.

The phone calls received are 26 minutes and 59 seconds of various phone calls that took place between OSHP Dispatch, Ashtabula County Sheriff's Office Dispatch (ACSO) and an OSHP Supervisor. The OSHP Supervisor is heard advising OSHP officers to back off the pursuit to monitor. When the shots-fired communication was heard, OSHP Dispatch called ACSO Dispatch to figure out if any officers were shot or just the subject on the motorcycle.

The OSHP Supervisor called dispatch to tell them he was en route due to an OSHP Officer shooting at the subject. Soon after, Lieutenant Beaver called OSHP Dispatch. Dispatch advised Lieutenant Beaver that the ACSO were in pursuit of a motorcycle when the motorcycle crashed and caught on fire, when officers shot, resulting in the subject being deceased. The rest of the phone calls were speaking of scene security, as well as media control.
