SUMMARY:

The North Olmsted Police Department requested crime scene assistance processing the scene of an Officer Involved Critical Incident (OICI) located at 5219 Berkshire Drive, North Olmsted, Ohio 44070.

DETAILS:

On Wednesday November 13th, 2023 at approximately 10:00am S/A Ed Staley met S/A Matt Armstrong at the Ohio Bureau of Criminal Investigation facility in Richfield, Ohio. S/A Armstrong had recovered clothing from the Cuyahoga County Medical Examiner's Office concerning an Officer Involved Critical Incident (OICI) on November 4th, in North Olmsted, Ohio.

At the Richfield facility, S/A Staley met with S/A Matt Armstrong who presented the clothing worn by the subject involved in the Officer Involved Critical Incident (OICI) in North Olmsted on November 4th, 2023.

S/A Staley opened the drying room rack containing articles of clothing. First item was a white athletic type shoe. S/A Staley photographed and documented the shoe. S/A Staley noted reddish-brown stains on the shoe.

Second item a pair of blue colored underwear. S/A Staley photographed and documented the underwear and the reddish-brown stains.

Third light colored under shirt size large. S/A Staley photographed and documented the under shirt. S/A Staley noted reddish-brown stains.

Fourth item tan colored jeans. S/A Staley photographed and documented the tan jeans. S/A Staley noted reddish-brown stains and four possible defects. S/A Staley also noted in the tan jeans were a pack of cigarettes, five-dollar bill, Visa card (██████████), black cloth with fifty-

dollar bill within the material. *(Fifty-dollar bill was covered in reddish-brown stains and appeared to be severely damaged).*

Fifth item was another shirt size large with reddish-brown stains and three possible defects. S/A Staley photographed and documented the shirt.

Sixth black colored pull over jacket. S/A Staley photographed and documented the pull over jacket. S/A Staley noted reddish-brown stains and three or four possible defects.

Seventh item a black hooded sweat shirt size 2XL. S/A Staley photographed and documented the hooded sweat shirt and the reddish-brown stains. S/A Staley noted possibly six defects to the sweat shirt.

All items of evidence were retained by the Ohio Bureau of Criminal Investigation to be held as evidence.

The photographs were uploaded into the Matrix record retention database. A USB copy of the photographs was made and disseminated to the Ohio Bureau of Criminal Investigation to be placed into their respective case file.
