Narrative:

On December 21, 2022, the Ohio Bureau of Criminal Investigation (BCI) was contacted by the Sidney Police Department (SPD) to conduct an independent investigation into the facts and circumstances surrounding an Officer-Involved Critical Incident (OICI) which occurred at the Sidney Foodtown, 1010 Wapakoneta Avenue, Sidney, Ohio of Shelby County.

BCI Agents from the Special Investigations Unit (SIU) Special Agents (SA) Perry Roeser, Richard Ward, Steve Seitzman, Lauran Frazier, Ken Smith, Chris Hamburg, Ryan Emahiser, and Tyler Price responded to the scene. Additionally, BCI's Crime Scene Unit was requested for evidence processing. SA Sara Taylor was assigned as the lead crime scene agent, and SIU SA Roeser was designated as the lead for the criminal investigation.

Sidney Police Captain Jerry Tangerman (Tangerman) reported his department received 911 calls related to a disturbance inside the grocery store, a man with a gun. When officers arrived at the location, the man with the gun, later identified as Todd Jordan, refused to comply with officers' commands. It was reported Jordan reached into his coat pocket and brandished a firearm. Four (4) police officers discharged their firearms in the direction of Jordan. Jordan was transported to an area hospital but succumbed to the injuries.

Acting Sidney Police Chief William Shoemaker provided SA Roeser with the official BCI Request for Assistance letter the following day. See attachment #1.

On December 21, 2022 at approximately 0800 hours we had an active shooting situation within the city limits. The location of the incident was 1010 Wapakoneta Ave. Sidney, Ohio 45365. Our incident number 22-15499

During the incident Four Sidney Police Officers fired their patrol rifles and killed the suspect Todd I Jordan, date of birth 8/27/1969

Captain Tangeman made contact with the Bureau of Criminal Investigations, and investigators responded to the scene.
