ASSIGNMENT: On Monday, September 5, 2022, while off duty, I received the following text message from the Cleveland Police Communication Control Section;

“4562 W. 174th St – FULL FIT CALLUP for CMHA on duty office involved shooting. 31 yo male shot in left lung and hip, pronounced by Dr. Renuart at 0135. CAD 259310”

At this time I contacted the Cleveland Police Communication Control Section and conferred with Chief Dispatcher and acknowledged receipt of the aforementioned text message. I then conferred with Sgt. Reese after which I proceeded to the scene and conducted the following investigation;

INTERVIEW: While in company with Lt. Schlacht 8553 I canvassed the immediate area of the crime scene for potential witnesses. We knocked at the following addresses, to which was captured on my Wearable Camera System. The following are a synopsis of what we were told and should not be considered verbatim, these recordings were uploaded to Evidence.com under the original report number.

4643 E. 174th St. – No response, a card was left.

4645 E 174th St. – We were met with an uncooperative female who would not identify herself. However, she mentioned she was not awake.
