DISAPPROVAL, NOTE OF CITY OF MIDDLETOWN, \$45,000, FOR SPECIAL ASSESSMENTS.

Department of Industrial Relations, Industrial Commission of Ohio, Columbus, Ohio.

Re: Note of city of Middletown in anticipation of collection of special assessments in the amount of \$45,000.

GENTLEMEN:—The resolution of purchase adopted by the Industrial Commission May 31, 1922, provides for the purchase of bonds in the amount of \$45,000, issued for the purpose of providing funds to pay the property owners' portion of certain street improvements.

The transcript discloses that the securities authorized and intended to be delivered consist of a short time note in the amount of \$45,000, issued in anticipation of the levy and collection of special assessments for the improvement of certain streets, said note falling due not earlier than November 1, 1922, and before September 1, 1923.

Permit me to call your attention to section 1465-58 G. C., which authorizes the purchase of certain securities by the Industrial Commission, which section does not authorize the purchase of notes.

Therefore, without passing upon the validity of the note in question, I advise the commission not to purchase the same for the reason that it is not authorized by law to purchase that class of securities.
