Narrative:

On Wednesday, May 14, 2025, the investigation regarding the officer-involved critical incident that occurred in Medina Township, Ohio, on November 4, 2024, was presented to a Grand Jury in the Medina County Court of Common Pleas by the Medina County Prosecutor's Office. The Grand Jury declined to file criminal charges regarding the actions of Ohio State Highway Patrol in relation to the death of Charles Alexander.

All evidence in this case has been returned to the requesting agency. Special Agent Jesse Bynum and Special Agent Supervisor Charles Moran reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.


