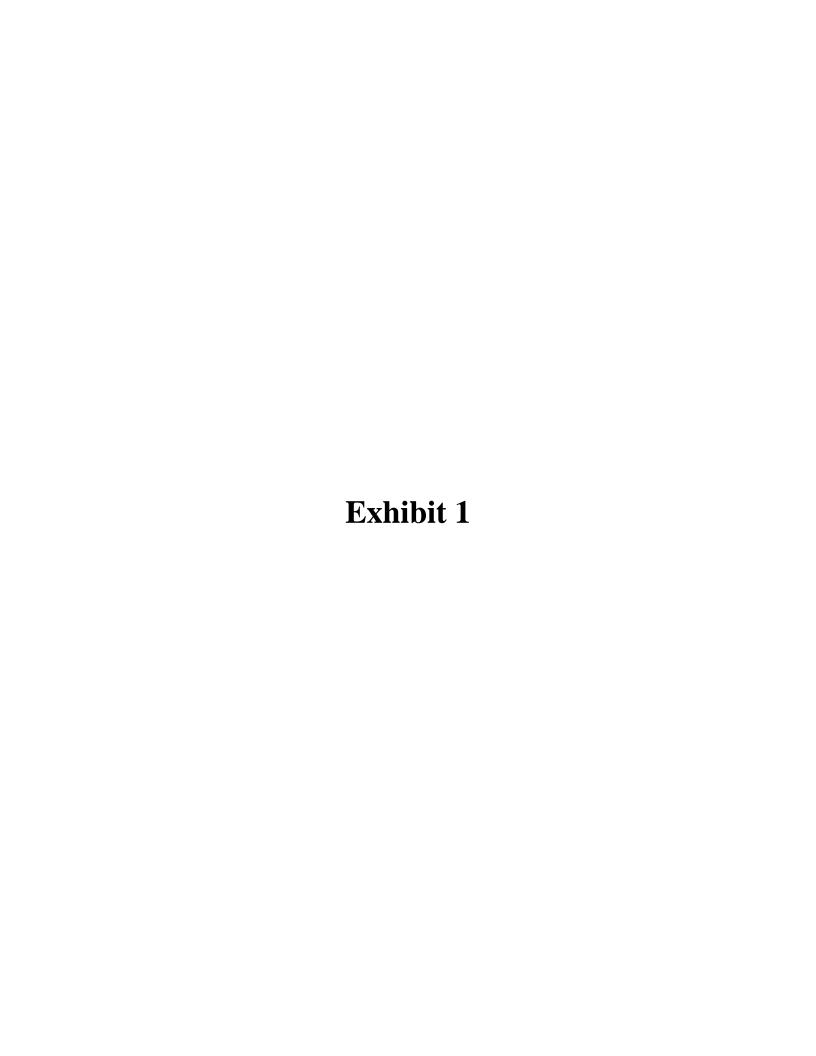
On December 21, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested to investigate the facts and circumstances surrounding an Officer-Involved Critical Incident (OICI) that occurred at Sidney Foodtown, located at 1010 Wapakoneta Avenue, Sidney, Shelby County, Ohio 45365. The OICI occurred when Sidney police officers encountered Todd I. Jordan (Jordan), who was armed with a gun inside Sidney Foodtown.

On January 4, 2023, BCI Special Agent Steven Seitzman (SA Seitzman) emailed Botkins Police Chief Mark Jordan (Chief M. Jordan) requesting any records the Botkins Police Department had related to Jordan. Chief M. Jordan located one report from 2018 and sent it to SA Seitzman. SA Seitzman reviewed the report and discovered that Jordan was the reportee. He reported that he was dissatisfied with the motel he had been staying at long-term. No formal police action was taken during that encounter. The report is attached below.

On Sunday June 10, 2018 at approximately 0146 hours both Chief Wirick from Jackson Center PD and I were dispatched to the Budget Host Inn at 505 E. State Street in Botkins, Ohio. We met the above reportee who stated he was tired of the noise and problems in the motel and was a long term resident who had just paid in advance for two week and he wanted his money back and wanted to leave. He stated that he spoke with the night desk clerk, Gary Brown, and he was unwilling to give him a refund. I spoke with Brown and he showed me the hand written records of the guest and he was unsure if the guest had paid for two weeks in advance and told the guest that he could contact the owner, Jason Miller, in the morning. I spoke with the reportee again and he stated that he was not really wanting to check out and that everything would be fine. He stated he would speak with Miller in the morning. The reportee did not have a phone number. No further action taken.
