DEAR SIR:—This will acknowledge receipt of a carbon copy of your letter to

Albert Spievack, First National Bank Building, Cincinnati, Ohio, under date of May 9, 1928, inclosing therewith proposed articles of incorporation of the "American Brotherhood of Coach-Operators."

I am returning the same to you herewith without my approval endorsed thereon.

The articles of incorporation are on the legal form of articles under the general corporation act of Ohio. Under the provisions of Section 8623-97, General Code, articles of incorporation of designated classes are required to comply with the provisions of the act under which they are proposing to operate and not under the general corporation law.

While no statement is made of the section under which these articles of incorporation are taken out, the purpose clause recites, "A mutual protective society." The sections governing this class of company are Sections 9427, et seq., General Code.

Section 9428, General Code, provides that the trustees therein provided for shall not be less than five nor more than fifteen. These articles as proposed only contain the names of three trustees.

I am therefore returning the same to you herewith, without my approval.
