Investigative Activity: Dash Camera and Body Camera Review  
Activity Date: June 13, 2021  
Activity Location: 5714 South Park Boulevard, Parma, Ohio

As part of the investigation into the events of June 13 & 14, 2021, involving the Parma Police Department, the Southeast Enforcement Bureau's SWAT Team and Kevin Giesel (Giesel), a review of body camera footage and dash camera footage was conducted by SA Prill. The following documents the video footage provided to Special Agent (SA) Jared Prill (Prill) by the Parma Police Department:

**Disc #1 of 34**

Dash camera of car #189, Officer Jonathan Kaniecki (Kaniecki)

June 13, 2021 (Start time 14:06:020 End time 14:48:17)

- At approximately 14:06:48 hours, a gray in color Ram truck, known from the investigation to be driven by Giesel, is turning onto Brookpark from State Road at the BP Gas Station.
- At 14:06:53 hours, Kaniecki initiates his vehicle's overhead lights and turns around in the BP's parking lot to attempt to stop Giesel.
- Kaniecki travels eastbound at speeds of approximately 87 mph in an effort to catch up to Giesel who is traveling at an extremely high rate of speed. (It is known from the vehicle's camera that the overhead lights are activated and a siren can be heard on the recording.)
- Kaniecki closes the gap with Giesel as the two vehicles turn onto Liggett Drive in Parma. Giesel immediately accelerates at a high rate of speed down Liggett toward South Park Boulevard.
- At approximately 14:08:30 hours, Giesel has made it to his residence at 5714 South Park Boulevard. Kaniecki arrives right behind Giesel and parks at the end of the driveway. Kaniecki immediately is heard yelling verbal commands to Giesel to show his hands, while exiting his patrol car. These commands include yelling at Giesel to get on the ground.
- Giesel fails to comply with officers' commands and is able to barricade himself inside the residence.

- At approximately 14:10:55 hours, radio traffic is heard advising officers that Giesel had discharged a firearm at an off-duty uniformed officer and assaulted a female before fleeing. This radio traffic also relayed information from Cleveland PD that the male had attempted to kidnap the involved female.
- At approximately 14:12:44 hours, an officer at the BP Gas Station puts out on the radio that Giesel is known to have numerous firearms inside the residence and he is now barricaded in.
- At approximately 14:14 hours, officers request a telephone number for Giesel in an effort to establish communications.
- At 14:14:51 hours, an officer is heard over a loud speaker advising Giesel that they wish to talk with him and state they will call his phone to establish this communication. It is known, at this time, that a perimeter is established around the home.
- Routine announcements are heard over a loud speaker requesting Giesel to communicate with officers.
- At approximately 1420 hours, an officer can be heard on the camera system speaking with Giesel on a phone.
- At approximately 14:23:50 hours, an officer can be heard saying that Sergeant Nathan Savetski (Parma SWAT Commander) had been notified.
- At approximately 14:25 hours, officers are heard deploying less-lethal force options on the perimeter of 5714 South Park.
- At approximately 14:32 hours, an officer is heard making contact with Giesel on the phone again. This officer is clearly attempting to build a dialogue with Giesel in an effort to negotiate a peaceful ending. This phone call lasts for approximately 10 minutes or longer.

June 13, 2021 (Start time 14:07:57 End time of 14:36:00)

- At 14:09 hours, radio traffic is heard confirming that Giesel has barricaded himself inside his residence after fleeing BP. This traffic confirms Giesel had brandished a firearm and discharged it at the BP Gas Station and that the assaulted female may have been a kidnapping victim.

- At 14:15:41 hours, Mackensen is on scene and is out of his vehicle. Numerous cruisers are already on scene at this time establishing a perimeter. An officer is heard issuing commands over a loud speaker to Giesel.
- Mackensen procures a nonlethal shotgun and takes up a position on the perimeter in front of 5714 South Park Boulevard. Mackensen remains in this position until the end of the recording at 14:36:00 hours.

**Disc #2 of 34**

Body-worn camera of Officer Nathan Ciarrone (Ciarrone) #595

June 13, 2021 (Start time 14:08:48 End time of 14:37:19)

- At approximately 14:09:23 hours, Ciarrone arrives at the residence of 5714 South Park Boulevard. Upon his arrival, other officers on scene can be heard yelling verbal commands to Giesel.
- At approximately 14:09:27 hours, Giesel is seen exiting the side door of his residence, going to the passenger door of his truck to retrieve his dog. Officers have their firearms drawn and pointed at Giesel while ordering him to show his hands. Giesel fails to comply or even acknowledge these commands and goes back inside the side door of the home at 14:09:39 hours.
- At 14:10 hours, Ciarrone takes up perimeter position covering the back door of the 5714 South Park.
- Ciarrone remains in this position until the end of the recording at 14:37:19 hours.

**Disc #3 of 34**

Body-worn camera of Officer Jonathan Kaniecki #550 (Kaniecki's vehicle's dash camera was reviewed in Disc #1)

June 13, 2021 (Start time 14:09:05 End time 14:37:10)

- At 14:09:17 hours, Kaniecki is on scene at the residence of 5714 South Park Boulevard. He is out of his vehicle with his firearm drawn. Giesel's gray in color Dodge Ram can be seen in the driveway of the home.
- At approximately 14:09:34 hours, the side door of the residence opens; Giesel exits the home, opens the passenger side door of his truck and then returns inside the home. Giesel does not acknowledge officers or their commands at this time.

- Kaniecki obtains a phone number for Giesel from dispatch and utilizes a cell phone to attempt contact with Giesel at approximately 14:15 hours. At the same time, numerous commands are being issued to Giesel via a loud speaker.
- Until the recording ends at 14:37:10 hours, the recording documents a perimeter being established, multiple force options being deployed and attempted communications with Giesel, who remained inside the home without complying.
- At approximately 14:31:48 hours, Kaniecki contacts Giesel, via the phone, and attempts to establish a report with him.

Body-worn camera of Officer Evan Mackensen #515 (additional footage of Mackensen's body camera was reviewed on Disc #2.)

June 13, 2021 (Start time of 14:36:01 End time of 15:04:06)

- The recording shows officers on the perimeter of 5714 South Park Boulevard as the standoff with Geisel unfolds. The video shows officers having lethal force and less-lethal options readily available.

June 13, 2021 (Start time of 14:37:11 End time of 15:05:14)

Body-worn camera footage of Officer Jonathan Kaniecki #550

- At the start of the recording at 14:37:11 hours, Kaniecki can be heard talking with Giesel on the phone. Kaniecki works hard to establish a friendly report with Giesel in an effort to get him to surrender to law enforcement. The phone call ends at approximately 14:44:41 hours.
- At 1450 hours, officers on the perimeter are heard yelling that they observed movement at the side door of the residence. Prior to this, they advised they observed movement at the window of the home. The advising officers state they saw Giesel crack open the side door of the home but not come out.
- At approximately 14:52:00 hours, officers attempt to make contact with Giesel via the phone. Giesel does not answer the call.
- At approximately 14:54:33 hours, an officer is heard on the loud speaker advising Giesel to answer his phone.

- At approximately 15:00:17 hours, officers advise that Giesel was going to let his dog out of the house to use the bathroom. It is known that this information was obtained from an officer being on the phone with Giesel.
- The recording ends at 15:05:14 hours, with officers holding the perimeter on 5714 South Park Road; while an officer is on the phone engaging Giesel, attempting to get him to surrender.

Dash camera footage from vehicle #189 driven by Officer Kaniecki #550

- The cruiser's camera system has a good visual of the front door of 5714 South Park but not of the side door. See the body-worn camera notes from Disc #5 for more details.

Body-worn camera of Officer Nathan Ciarrone #595

- At approximately 14:37:20 hours, Ciarrone is on the perimeter of the back of 5714 South Park Boulevard.
- At approximately 15:00:20 hours, radio traffic advises Ciarrone that Giesel will be letting his dog out the back of the residence.
- At 15:01:10 hours, Ciarrone witnesses Giesel let his dog out. At this time, Ciarrone observes Giesel wearing a shoulder holster with no shirt on and blue jeans. He also advises there are spare magazine holders on the shoulder holster.
- At approximately 15:01:53 hours, Ciarrone witnesses Giesel return inside the residence.
- The recording ends at 15:05:42 hours with Ciarrone holding his position on the back perimeter.

- At approximately 15:15:40 hours, officers are heard on a loud speaker trying to negotiate with Giesel. These commands continue for several minutes.
- The recording ends at 15:32:11 hours with Mackensen still holding his perimeter position.

Body-worn camera of Officer Jonathan Kaniecki #550

- At the start of the recording, Kaniecki is holding a perimeter position with a patrol rifle in the front of the residence. An officer can be heard on the phone with Giesel in the background of the recording negotiating with Giesel to surrender.
- At approximately 15:17 hours, an officer is heard on a loud speaker attempting to negotiate with Giesel.
- At approximately 15:18 hours, an officer can be seen and heard talking with Giesel on the telephone attempting to get him to surrender to law enforcement. This conversation lasts for several minutes until approximately 15:24:53 hours.
- The recording ends with Kaniecki remaining in his position in the front of 5714 South Park Boulevard.

Dash camera recording from vehicle #189 driven by Officer Jonathan Kaniecki #550

- The vehicle is parked in the front of 5714 South Park Boulevard and has a good vantage point of the front door of the residence. However, there are no significant events recorded during the above-time period.

- The recording starts with Mackensen in a perimeter position in the front of 5714 South Park Boulevard. At this time, Mackensen has a less-lethal shotgun deployed.
- At approximately 16:01 hours, radio traffic is heard on the recording stating that Giesel is moving the blinds on a window on the back half of the residence.
- At approximately 16:11 hours, radio traffic is heard stating that Giesel had closed the blinds on a window of the residence.
- At approximately 16:27:26 hours, Mackensen and other officers observe Giesel come to the front door of the residence. They immediately begin giving verbal commands to Giesel, who does not comply.
- At approximately 16:27:50 hours, Mackensen advises that Giesel has returned inside the home and shut the door. A physical description of Giesel is put out over the radio indicating that he is still shirtless and wearing a shoulder holster.

- The recording starts with Kaniecki in a perimeter position in the front of 5714 South Park Boulevard carrying a patrol rifle.
- At approximately 16:27:50 hours, Kaniecki responds to Giesel coming to the front door by issuing verbal commands. Giesel does not to comply with the commands and closes the front door. Kaniecki advises that Giesel is still shirtless with a shoulder holster but unaware if there was a weapon on Giesel's person.

- The vehicle is parked in front of 5714 South Park Boulevard with the camera covering the front door of the residence.
- At the start of the recording, an officer can be heard on the phone with Giesel who advised the officer that he threw a revolver out of the window of his vehicle while fleeing from the BP Gas Station. Officers are dispatched to attempt to recover this firearm.

- At approximately 16:27:32 hours, the front door of the residence is seen opening and a person can be seen inside (though heavily obstructed do to glare). Officers are heard issuing verbal commands; however, the door is closed at 16:27:59 hours.
- At approximately 16:31:08 hours, an officer can be heard saying Giesel is sending his dog out into the back yard of the home. This is relayed to other officers.
- At 16:31:28 hours, an officer on the rear perimeter advises that Giesel does have a firearm and has the firearm in his hand.
- At approximately 16:32:31 hours, the officer who witnessed Giesel with the firearms advises that he has returned inside the home.
- -At approximately 16:42:21 hours, vehicle #189 is moved from its location in the front of 5714 South Park Boulevard to allow an armored personnel carrier carrying SEB SWAT officers to take over the position. The vehicle is moved one residence south of Giesel's address and could still record the front door of 5714 South Park Boulevard.

- At 16:35:13 hours, Kaniecki's vehicle was moved from the front of the residence in order for an armored personnel carrier to take up a position in front of the home. The armored personnel carrier arrives at 16:36:00 hours, and takes a position at the end of Giesel's driveway.
- At approximately 16:38 hours, Kaniecki advises the driver of the APC carrier of Giesel's age and that he is armed.
- The recording ends with Kaniecki in a perimeter position on the passenger side of the armored personnel carrier in the front of 5714 South Park Boulevard.

Body-worn camera of Officer Nathan Ciarrone #595

- The recording is only a 32-second clip of Ciarrone in a perimeter position covering the back of 5714 South Park Boulevard. No significant events are observed.

Dash camera of vehicle #189 driven by Officer Jonathan Kaniecki #550

- The recording begins with the vehicle parked south of 5714 South Park Boulevard recording the front door of Giesel's residence.
- At approximately 18:06:03 hours, officers advise that Giesel is opening the front door of his residence. Giesel is observed standing in the entrance way to the house with his dog and knocking on his door pointing at the officers.
- An officer can be heard on the radio that they observe Giesel yelling at police with the screen door closed to his residence at approximately 18:06:40 hours.
- At 18:06:50 hours, Giesel opens the screen door that he was standing behind. Giesel can be seen with his dog on a leash yelling at the police in an animated manner. Giesel can be seen slamming the screen door multiple times.
- At approximately 18:07 hours, Giesel is seen by an officer with a cane in his hand. This information is relayed by the officer via the radio.
- At 18:08:08 hours, Giesel exits the house but remains next to the door. Giesel is very animated during this exchange and can be seen yelling at officers.
- At approximately 18:08:36 hours, it is advised over the radio that an officer has a clear shot with the less-lethal shotgun. The scene commander denies the deployment of less-lethal rounds at this time.
- At approximately 18:10:29 hours, an extremely animated Giesel is seen dropping his pants and shows his penis to officers on scene. Again, a request is made to deploy less-lethal rounds.
- At 18:11:01 hours, Giesel pulls his underwear down and stands outside of the front doorway of his residence exposing himself to officers. At 18:11:15 hours, officers again ask the scene commander to deploy less-lethal shotgun rounds. This request is denied.
