**Narrative:**

On Tuesday, March 21, 2023, at about 0420 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) went to the Brookfield Township Police Department (BTPD) to make contact with the involved law enforcement officers from the Trumbull County Sheriff's Office (TCSO), the BTPD, and the Vienna Township Police Department (VTPD).

SA Moran met with VTPD Officer (Ofc.) ██████████ (██████). SA Moran asked Ofc. ██████████ if he wanted to provide a statement to BCI and he indicated that he did not want to provide a statement to BCI at that time. SA Moran asked Ofc. ██████████ if he had any legal counsel assigned from either the Fraternal Order of Police (FOP) or the Ohio Patrolmen's Benevolent Association (OPBA). Ofc. ██████████ said he did not have legal counsel assigned and was not a member of either union. Ofc. ██████████ indicated that he would be seeking his own legal counsel. SA Moran provided Ofc. ██████████ with a business card and requested Ofc. ██████████ to have his legal counsel call SA Moran to schedule a time for Ofc. ██████████'s statement if he chose to provide one.

SA Moran requested to check Ofc. ██████████'s pistol and extra ammunition magazines. Ofc. ██████████ showed SA Moran his magazines and the magazine from his pistol. Ofc. ██████████ carried a Glock pistol. He had 17 cartridges in both of his extra magazines. Ofc. ██████████ had 16 cartridges in the magazine inside his pistol and one cartridge in the chamber. Ofc. ██████████ told SA Moran that he did not fire his pistol during the incident. Ofc. ██████████ said he fired his rifle during the incident. He said his rifle was an Arrow Precision brand and was personally owned.

SA Moran took four photographs (front, left side, rear, right side) of Ofc. ██████████ in his uniform that he wore at the time of the incident. Ofc. ██████████ was equipped with a body-worn camera (BWC) at the time of the incident.

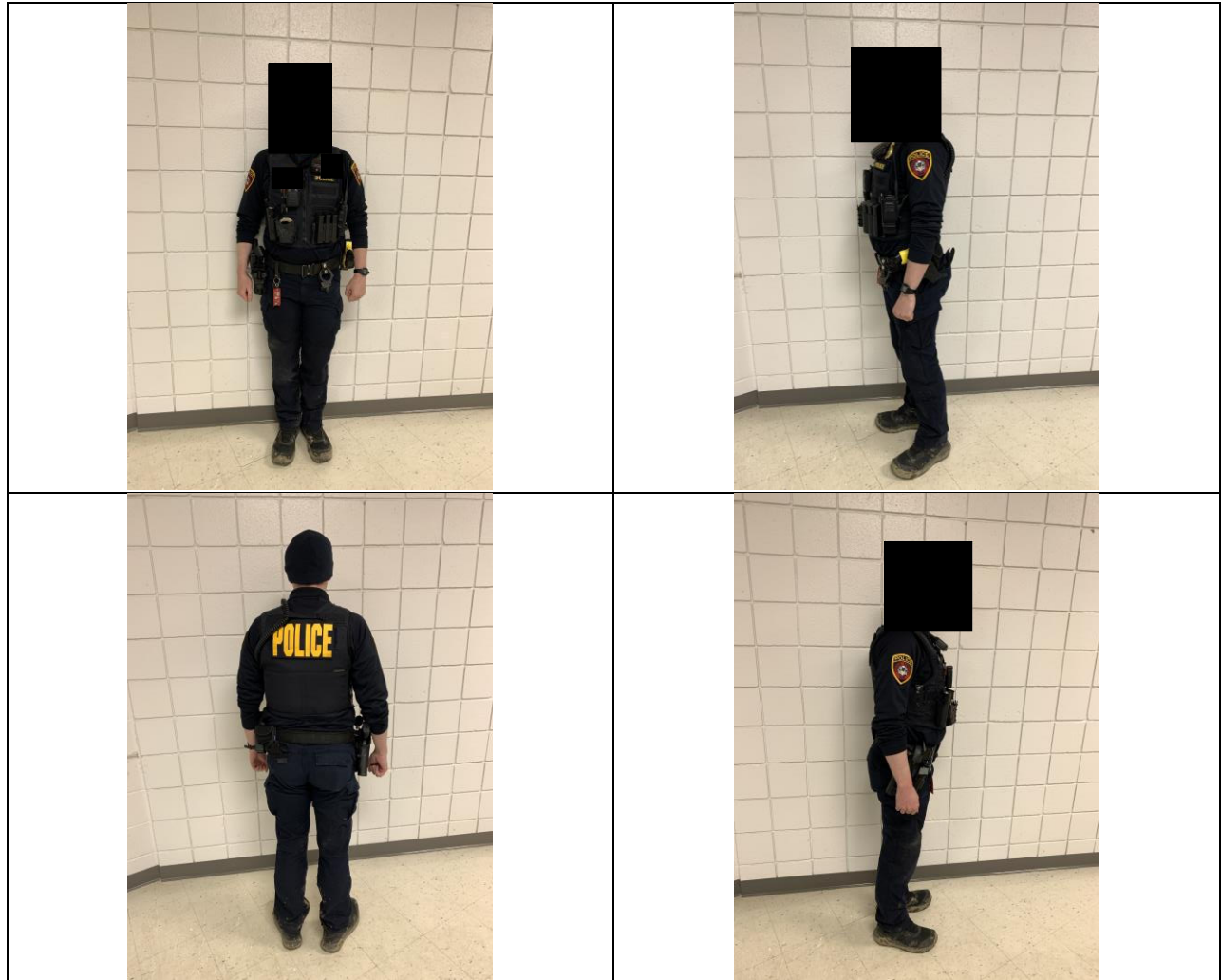

[REDACTED] said he usually carried his pistol with 17 cartridges in the magazine and one cartridge in the chamber. He said he recently (within the last month) shot a deer with his pistol and had not replaced the ammunition used. Ofc. [REDACTED] told SA Moran that he did not fire his pistol during the incident. Ofc. [REDACTED] said he fired his rifle during the incident. He said his rifle was an Wyndham Arms brand and was departmentally owned.

SA Moran took four photographs (front, left side, rear, right side) of Ofc. [REDACTED] in his uniform that he wore at the time of the incident. Ofc. [REDACTED] was equipped with a BWC at the time of the incident.

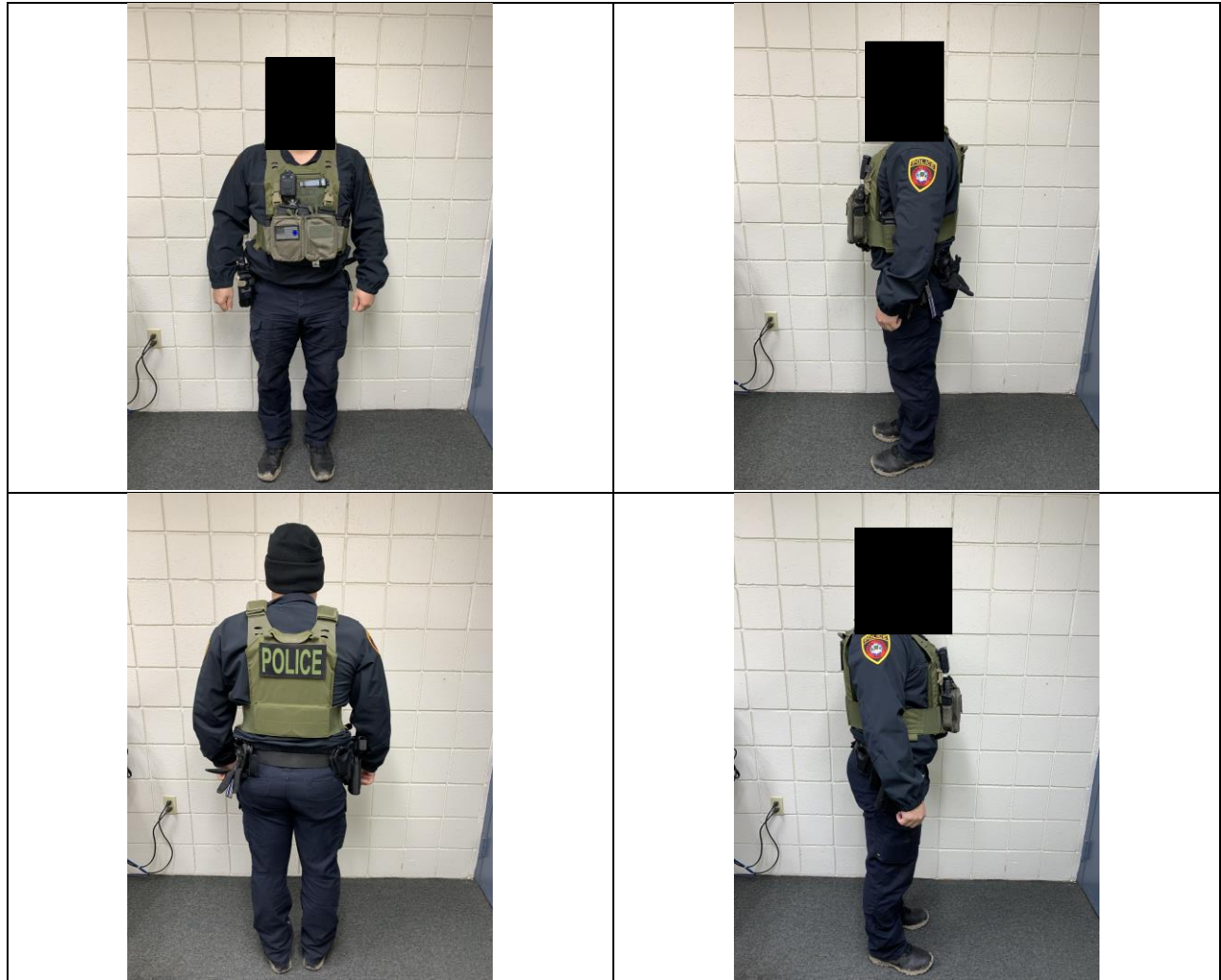

SA Moran provided Deputy [REDACTED] with a business card and requested Deputy [REDACTED] to have his legal counsel call SA Moran to schedule a time for Deputy [REDACTED]'s statement if he chose to provide one.

SA Moran requested to check Deputy [REDACTED]'s pistol and extra ammunition magazines. Deputy [REDACTED] showed SA Moran his magazines and the magazine from his pistol. Deputy [REDACTED] carried a Glock pistol. He had 15 cartridges in both of his extra magazines. Deputy [REDACTED] had 12 cartridges in the magazine inside his pistol and one cartridge in the chamber. Deputy [REDACTED] said he usually carried his pistol with 15 cartridges in the magazine and one cartridge in the chamber. He said he shot a few deer recently and had not replaced the ammunition used. Deputy [REDACTED] said he did not fire his pistol during the incident. Deputy [REDACTED] said he fired his rifle during the incident. He said it was an Arrow Precision brand, it was cerakoted, and it was personally owned.

SA Moran took four photographs (front, right side, rear, left side) of Deputy [REDACTED] in his uniform that he wore at the time of the incident. Deputy [REDACTED] was not equipped with a BWC at the time of the incident. (The TCSO does not have BWCs.)

He said it was a Daniel Defense brand and his last name was on one of the magazines.
