John Perry was listed as a victim in the above matter. The report narrative reads:

I was dispatched to 2212 Tryon Road, reference to a reported theft of a motor vehicle from that location. Dispatch advised the vehicle was located in the parking lot of A. Luis Supply on Main Avenue by an Ashtabula City Police Unit.

Upon my arrival, I met with the vehicle owner John Perry. John told me last night he had fallen asleep on his couch at around 2300 hours. He said, this morning he received a call from the Ashtabula City Police that his 1997 Toyota was found in the parking lot of A.Luis Supply. John went on to say, someone had must have entered his unsecured home, while he slept, and took the vehicle keys that was last place on the kitchen table.
