

By this lease, there is leased and demised to the lessee above named the right to occupy and use for cottage site and docklanding purposes, that portion of the State Reservoir land that is included in the west-half of Lot No. 5, of the allotment of lands west of Summerland Beach on the south shore of Buckeye Lake, as laid out by John I. Miller and E. E. Booton, on the second day of August, 1919, in the southeast quarter of Section 28, town 17, range 18, Fairfield County, Ohio. This lease is for a term of fifteen years and provides for an annual rental of \$35.00.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.

APPROVAL — GRANTS OF EASEMENT, STATE OF OHIO THROUGH CONSERVATION COMMISSIONER, 23 GRANTORS DESIGNATED AS TO NUMBERS, GRANTS TO PROPERTY IN WAYNE, UNION AND PERRY TOWNSHIPS, FAYETTE COUNTY, OHIO, CERTAIN LANDS FOR PUBLIC FISHING GROUNDS, AND TO IMPROVE THE WATERS OR WATER COURSES PASSING THROUGH AND OVER SAID LANDS.
