**ASSIGNMENT:**

On Thursday, June 2<sup>nd</sup>, 2022, while assigned the Cleveland Division of Police, Homicide Unit/ F.I.T, I received an assignment via-text at 1802 hours, from Cleveland Police Communication Control Section which read; *FULL UDFIT @ 3495 E. 98 St, CMHA involved in shooting---50 yr male gsw to chest. CMHA officer sustained minor injuries. CAD #155158*

Upon receiving this notification via-text, I conferred with Cleveland Police Department, Communications Control Section (Radio), Chief Dispatcher Foley #218, via-landline in regards to this assigned incident. I also conferred with my supervisor, Sgt. Reese #9266 and Sgt. Gomez #9135, in regards to the reception of this assignment.

After conferring with Sgt. Reese #9266 and Sgt. Gomez #9135, while in company with Detective(s); Cramer #346 and Lentz #897, I responded to the area of 3459 E. 98<sup>th</sup> Street, to canvass the area, process the scene and further investigate this incident.

**EVIDENCE:**
