MY DEAR GOVERNOR:—This is to acknowledge the receipt of your recent communication submitting for my examination and approval a certain deed form in triplicate of a deed to be executed by the state of Ohio through you, as Governor, conveying to The Pennsylvania Railroad Company, its successors and assigns, an easement in, upon and over a strip of land sixteen feet in width in East Union Township, Wayne County, Ohio, which strip of land, more particularly described by metes and bounds, course and distances in said deed form, is to be used by said railroad company for the construction of a side track to serve the state institution for the feeble minded at Apple Creek, Ohio.

Upon examination of the deed form submitted, I find the same to be in all respects legal and in proper form and that when the same is executed and acknowl-

edged by you, as Governor of Ohio, in accordance with law and the form of said deed, the deed thus executed will be legally sufficient to convey to The Pennsylvania Railroad Company, its successors and assigns, an easement in the property described in the deed for the uses and purposes therein stated.

APPROVAL, CONTRACT BETWEEN STATE OF OHIO AND THE H. E. CLEFMAN COMPANY, CLEVELAND, OHIO, FOR ALTERATIONS FOR OHIO STATE HANGAR, CLEVELAND AIRPORT, CLEVELAND, OHIO AT AN EXPENDITURE OF \$4,395.00. SURETY BOND EXECUTED BY THE AETNA CASUALTY AND SURETY COMPANY OF HARTFORD, CONNECTICUT.

DEAR SIR: You have submitted for my approval a contract between the State of Ohio, acting by and through yourself as Adjutant General of Ohio and Director of State Armories, and the H. E. Clefman Company of Cleveland, Ohio. This contract covers the construction and completion of alterations in and addition to Ohio State Hangar, Cleveland Airport, Cleveland, Ohio, in accordance with the form of proposal dated April 16, 1932. Said contract calls for an expenditure of four thousand three hundred and ninety-five dollars (\$4,395.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. In addition, you have submitted a contract bond, upon which the Aetna Casualty and Surety Company of Hartford, Connecticut, appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared, notice to bidders was properly given, bids tabulated as required by law and the contract duly awarded. Also it appears that the laws relating to the status of surety companies and the workmen's compensation have been complied with.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other data submitted in this connection.
