F. Silliman's survey of said canal, made under the direction of the State Board of Public Works in the summer of 1912.

APPROVAL, LEASE TO RESERVOIR LAND IN INDIAN LAKE FOR THE RIGHT TO OCCUPY AND USE FOR COTTAGE SITE AND DOCKLANDING PURPOSES—R. R. RITCHIE.

DEAR SIR:—This is to acknowledge the receipt of a communication under

date of June 7, 1933, from the chief of the bureau of inland lakes and parks of the division of conservation in your department, submitting for my examination and approval a certain reservoir land lease in triplicate executed by the conservation commissioner to one R. R. Ritchie of Dayton, Ohio. By this lease, there is granted to the lessee above named for the stated term of fifteen years and for an annual rental of twenty-four dollars, payable semi-annually, the right to occupy and use for cottage site and docklanding purposes that portion of the State Reservoir land including Lot No. 19 of the Revised Plat of Minnewauken Island in Indian Lake; said island being a part of Virginia Military Survey No. 12276 in Stokes Township, Logan County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by the conservation commissioner and by R. R. Ritchie, the lessee therein named. I further find, upon examination of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with the provisions of section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.
