On August 24, 2023, Ohio Bureau of Criminal Investigation (BCI) Crime Scene Technician (CST) Amy Gill and Special Agent (SA) Sarah Taylor, along with members of the BCI Special Investigations Unit (SIU), were assigned to assist the Columbus Police Department (CPD) with an officer involved critical incident. It was reported that on the evening of August 23, 2023, CPD responded to a call about a male in violation of a protection order. The male, later identified as Jamie Overstreet (Overstreet), fled from officers in a vehicle. In the course of the pursuit, the vehicle was involved in an accident with several other vehicles; however, the pursuit continued. Once the vehicle came to a stop, Overstreet continued to flee from officers on foot. It was reported that while running, Overstreet brandished a firearm. CPD Officer fired his weapon, striking Overstreet. Overstreet was transported to Grant Medical Center where he was pronounced deceased.

BCI personnel arrived on scene at approximately 0105 hours. The area where the shooting took place was observed to be in a central courtyard, just north of 1382 Marion Road. A large section of the neighborhood, as well as part of Marion Drive North, were secured with crime scene tape. The scene was photographed as it was upon arrival and a Leica 3D scanner was utilized to further document the scene.

The vehicle that Overstreet was reported to have been driving was located near 1435 Marion Drive North. The vehicle, a black Chevrolet Monte Carlo (VIN: 2G1WX12K159200708) with temporary Ohio tag Q881811, was observed to have significant damage to the front driver side and the front driver wheel was torn down to the metal rim. CPD cruiser which Ofc. The five the driving, was located near 1387 Marion Drive North. In the parking lot to the south of the cruiser, five Speer 9mm cartridge casings were located on the ground near a parked vehicle. The five casings were collected together as item 1.

Several items of evidence were located on a sidewalk near an area of suspected blood, which led through the courtyard, just southeast of the parking lot. A Taurus Spectrum .380 caliber semi-automatic pistol with serial number 1F074703 was located on the ground. A seated magazine was observed in the firearm; however, it appeared broken. No cartridges were located in the magazine or the chamber of the firearm. The firearm and magazine were collected together as item 2. A magazine spring, baseplate, and follower were located on the ground near the firearm and collected together as item 3. Three .380 cartridges with various headstamps were also located nearby on the ground (item 4). A black cellphone in a black case was located in the grass near the sidewalk (item 5).

Upon further canvasing of the scene, a black Ford Taurus SE with Ohio tag JID 1638 was located in a parking lot outside of 1382 Marion Road. The vehicle appeared to have been struck by gunfire, as the front driver window was shattered. With consent from the owner, the vehicle was photographed and processed. A suspected ballistic event (BE) was located in the rear passenger door, just below the window, where the projectile appeared to perforate the interior door panel. When the door was opened, a projectile fell out of the vehicle onto the ground and was collected as item 7.



OHO BCI

CST Gill received two brown bags from SA Taylor, containing Overstreet's belongings, that had been collected at Grant Medical Center. Overstreet's clothing, including jeans with a belt, a black t-shirt with a suspected bullet hole, black underwear, black shoes, and black socks were collected as item 6. Inside the clothing, miscellaneous papers, an ID with the name Jamie Overstreet, and \$39.38 in US currency was observed. All items were collected together as item 6.1.

No additional items of evidentiary value were located and BCI personnel cleared the scene at approximately 0440 hours. At 0600 hours, CST Gill placed all items collected from Scenes 1 and 2 into the BCI Crime Scene Unit temporary evidence locker located in London, Ohio.

On August 25, 2023, at 1145 hours, CST Gill removed the evidence from the temporary evidence locker. At 1222 hours, the casings, firearm, and projectile (items 1-2, 7) from Scene 1 along with Ofc.
