Narrative:

On/about 2021-06-30, Ohio Attorney General's Bureau of Criminal Investigation (BCI) Special Agent (SA) Charlie Snyder (Snyder) was requested by BCI SA Jon Lieber to assist in this matter by reviewing and preparing total transcription of radio traffic involved.

SA Snyder was provided with a series of single track recordings involving the Southwest Enforcement Bureau (SEB) officer-involved critical incident that began on indicated date 2021-06-13, at indicated time of 20:18:45, and 7 hours, 31 minutes and 15 seconds in total duration.

SA Snyder prepared and completed a 30-page transcription with notes from that effort on 2021-12-02 that was uploaded into Matrix.
