Narrative:

Search Warrant Obtained

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) drafted a search warrant for a cell phone, Apple iPhone SE (Matrix evidence item 016), possibly belonging to the subject, Paul Wild III (Wild) relative to the officer-involved critical incident which occurred on Tuesday, March 21, 2023.

On Thursday, March 23, 2023, SA Moran met with Summit County Court of Common Pleas Judge Kelly McLaughlin (Judge McLaughlin). Judge McLaughlin reviewed the search warrant, search warrant affidavit, and application and order to seal. On Thursday, March 23, 2023, at approximately 1400 hours, Judge McLaughlin signed / authorized the search warrant.

Search Warrant Executed

On Friday, March 24, 2023, at approximately 1101 hours, SA Moran executed / served the aforementioned search warrant by submitting the cell phone to the BCI Cyber Crimes Unit (CCU).

During the search, the following items of potential evidence were seized:

- Reference Item T – 128GB USB flash drive with cell phone extraction data from Matrix evidence item 016, Apple iPhone SE, serial no. 359844400070247, SIM card 89011503277534066284, white colored in black and orange case, from BCI CCU on July 27, 2023

An inventory of the items seized was prepared with a copy provided to the BCI case file and the Summit County Clerk of Courts.
