Narrative:

On Friday, January 05, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received video footage from BCI SA Al Bansky. SA Bansky was informed that the videos contained footage from the body cameras recorded by the Canton Police Department (CPD).

SA Lieber reviewed the video recordings and noted the following:

This video is 10 minutes and 55 seconds in duration. The video is recorded by the body-worn camera (BWC) of Canton Police Department Officer (Ofc.) Trevor Stern (Stern). The time stamp at the beginning of the video is 12/05/2023 at 22:15:42.

The video begins showing Stern getting into the passenger side of a police vehicle. The vehicle drives out of a garage. At 22:16:12, sound can now be heard. At 22:21:24, radio traffic is heard directing Stern and Ofc. Trent Abel (Abel) to proceed to Aultman Hospital. At 22:12:12, Stern arrives at the hospital. Stern and Abel wait outside of the hospital until the ambulance arrives. At 22:26:23, Zachary Fornash is brought into the hospital on a gurney. At 22:26:37, the video ends.

This video is 1 minute and 04 seconds in duration. The video is recorded by the body-worn camera (BWC) of Canton Police Department Officer Trevor Stern. The time stamp at the beginning of the video is 12/05/2023 at 23:54:42. At 23:55:13, sound can now be heard. Stern has a brief telephone call and then returns inside the hospital. The video ends.

This video is 2 hours, 12 minutes, and 10 seconds in duration. The video is recorded by the vehicle dash camera of Canton Police Department Officer Trevor Stern. There is no time stamp on this video, therefore, any times referenced will be in elapsed time.

The video begins showing the hood of a vehicle facing a wall. At 0:06, sound turns off. The vehicle begins to drive. At 0:32, sound can now be heard. At 6:28, the vehicle arrives at the hospital. The view from the camera is shown below. This is the view for the remainder of the video.
