Narrative:

On December 21, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested to investigate the facts and circumstances surrounding an Officer-Involved Critical Incident (OICI) that occurred at Sidney Foodtown, located at 1010 Wapakoneta Avenue, Sidney, Shelby County, Ohio. The OICI occurred when Sidney police officers encountered Todd I. Jordan (Jordan), who was armed with a gun inside Sidney Foodtown.

On December 22, 2022, at 1120 hours, BCI Special Agent Steven Seitzman (SA Seitzman) received a text message from victim, Annette I. Wooddell (Annette) indicating that she had additional information to pass along. Annette advised SA Seitzman that her son, Travis David Gossard (Travis) was contacted on TikTok by the username "Lihhaamster," indicating that she had information regarding Jordan's plan the day of the shooting. According to Annette, Lihhaamster would not disclose the information without being paid.

SA Seitzman asked Annette how Lihhaamster came to communicate with Travis. She said Travis posted something on Jordan's TikTok page, which Lihhaamster must have seen. At some point, Lihhaamster reached out to Travis.

SA Seitzman asked Annette if Travis could forward screenshot images of the communication with Lihhaamster. Annette advised SA Seitzman that Travis deleted the conversations and was no longer able to access them.

Annette provided SA Seitzman with Travis' phone number.
