Narrative:

On May 24, 2024, at approximately 0700 hours, Special Agent James Keen (SA Keen) conducted a neighborhood canvass at the location of 27695 Tracy Road, Walbridge, OH 43465 regarding an Officer Involved Critical Incident. It should be noted that this complex is a trailer park consisting of lot numbers for addresses. The following are locations that SA Keen attempted to contact the resident.

Lot 300 (Blue Jacket Drive)– SA Keen contacted Anthony Goven. Goven stated that around 10:17–10:30pm last night, he saw what appeared to be a tall and skinny white male adult, wearing white t-shirt, run past his house. Goven stated the male ran east, and he remembered looking at the clock to check the time. Goven did not hear or see anything else of note.

Lot 299 (Alice Street)– SA Keen contacted Trenton Hulisz who stated he was at work last night and had nothing to report.

Lot 301 (Blue Jacket Drive)– No answer, SA Keen left a business card for follow-up.

Lot 303 (Vivian Street)– SA Keen contacted Maria Schofield who stated she was sleeping and did not see or hear anything.

Lot 305 (Vivian Street)– SA Keen contacted Jason Turner who stated he did not hear or see anything except for cop cars while he was leaving for work at 11 pm.

SA Keen did not observe any cameras on Vivian Street.

Lot 312 (Blue Jacket Drive)– No answer, SA Keen left a business card for follow-up. An eviction notice was observed on the front door, SA Keen did not know if the trailer was currently occupied.

Lot 313 (Blue Jacket Drive)– SA Keen contacted Lori Shipman who stated she did not hear or see anything related to the investigation.

Lot 317 (Florence Avenue)– SA Keen contacted Caleigh Instone. SA Keen conducted an audio recorded interview with Instone due to her hearing gunshots which was placed in the case file.

Lot 321 (Florence Avenue)– No answer, SA Keen left a business card for follow-up. The trailer has a doorbell camera which faces west toward Florence Avenue.

Lot 322 (Florence Avenue)– SA Keen contacted Chad Linke who stated he was leaving for work and could not talk due to being late. Linke did state that he heard gunshots last night but did not go into detail.

NOTE: This report only summarizes the information deemed by the author to be of the most relevance to the investigation and does not purport to contain all questions and answers from the interview. Further, this report was placed in a chronology to aid the reader's overall understanding of the information elicited during the interview and may not be reflective of the actual sequencing of questions.
