The contract is signed "M. G. Beck Electric Company, Contractor, by Merrill G. Beck, Mgr." The proposal and the contract bond are also signed "M. G. Beck Electric Company by Merrill G. Beck, Mgr."

I suggest that you secure from James L. Ford a letter to the effect that he is doing business as M. G. Beck Electric Company, that Merrill G. Beck is the manager of said business, and that said Merrill G. Beck had authority to sign the contract, proposal and bond.

Finding said contract and bond in proper legal form, subject to the exception noted in the next preceding paragraph, I have this day noted my approval thereon, conditioned upon your securing the letter above suggested, and return the same herewith to you, together with all data submitted in this connection.
